**PROPOSED AMENDMENTS TO  
SENATE BILL 907**

1 On page 1 of the printed bill, delete lines 14 through 22.

2 On page 2, delete lines 1 through 8 and insert:

3 “(3) If the applicant described in subsection (1) of this section is not the  
4 owner of the premises to be licensed under ORS 475A.290, the applicant shall:

5 “(a) Inform the owner in writing that the premises is intended to be li-  
6 censed under ORS 475A.290;

7 “(b) If the owner wishes to consent to the use of the premises for the  
8 purposes of manufacturing psilocybin, obtain from the owner the owner’s  
9 written signature, witnessed by a notary public, confirming ownership of the  
10 premises and consenting to the applicant’s use of the premises for the pur-  
11 pose of manufacturing psilocybin; and

12 “(c) Provide the owner’s witnessed signature as described in paragraph (b)  
13 of this subsection to the authority.

14 “(4) An owner who consents as described in subsection (3) of this section  
15 to the use of the owner’s premises for the purpose of manufacturing  
16 psilocybin may specify in the document that contains the owner’s witnessed  
17 signature the number of annual licensure terms for which the owner’s con-  
18 sent to the use of the premises is valid.

19 “(5) The authority shall cancel an application for a license under ORS  
20 475A.290 if the authority:

21 “(a) Is not able to verify ownership of the premises described in sub-

1 section (1) of this section; or

2 “(b) Does not receive, if the application is from an applicant described in  
3 subsection (3) of this section, the witnessed signature described in subsection  
4 (3) of this section.

5 “(6) The authority may adopt rules to carry out this section. Rules  
6 adopted under this section may include rules to establish a form for the  
7 purposes of this section.”.

8 On page 3, line 14, after the semicolon insert “and”.

9 Delete lines 15 through 27 and insert:

10 “(c) Must meet the requirements of any rule adopted by the authority  
11 under this section.”.

12 In line 36, after “section” insert “and, if the applicant or licensee is not  
13 the owner of the premises for which the license is being renewed, to submit  
14 with the application for renewal the owner’s written signature, witnessed by  
15 a notary public, confirming ownership of the premises and consenting to the  
16 applicant’s or licensee’s use of the premises for the purpose of manufacturing  
17 psilocybin, if the owner’s consent to the use of the premises is expired”.

18 On page 4, delete lines 11 through 28 and insert:

19 “(3) If the applicant described in subsection (1) of this section is not the  
20 owner of the premises to be licensed under ORS 475C.065 or 475C.085, the  
21 applicant shall:

22 “(a) Inform the owner in writing that the premises is intended to be li-  
23 censed under ORS 475C.065 or 475C.085;

24 “(b) If the owner wishes to consent to the use of the premises for the  
25 purposes of producing or processing marijuana, obtain from the owner the  
26 owner’s written signature, witnessed by a notary public, confirming owner-  
27 ship of the premises and consenting to the applicant’s use of the premises for  
28 the purpose of producing or processing marijuana; and

29 “(c) Provide the owner’s witnessed signature as described in paragraph (b)  
30 of this subsection to the commission.

1 “(4) An owner who consents as described in subsection (3) of this section  
2 to the use of the owner’s premises for the purpose of producing or processing  
3 marijuana may specify in the document that contains the owner’s witnessed  
4 signature the number of annual licensure terms for which the owner’s con-  
5 sent to the use of the premises is valid.

6 “(5) The commission shall cancel an application for a license under ORS  
7 475C.065 or 475C.085 if the commission:

8 “(a) Is not able to verify ownership of the premises described in sub-  
9 section (1) of this section; or

10 “(b) Does not receive, if the application is from an applicant described in  
11 subsection (3) of this section, the witnessed signature described in subsection  
12 (3) of this section.

13 “(6) The commission may adopt rules to carry out this section. Rules  
14 adopted under this section may include rules to establish a form for the  
15 purposes of this section.”.

16 On page 5, line 29, delete “subsections (3) and”.

17 In line 30, delete “(4) of”.

18 On page 6, delete line 8 and insert “under ORS 475C.033:

19 “(A) A report describing the applicant’s or licensee’s electrical or water  
20 usage; and

21 “(B) If the applicant or licensee is not the owner of the premises for  
22 which the license is being renewed, the owner’s written signature, witnessed  
23 by a notary public, confirming ownership of the premises and consenting to  
24 the applicant’s or licensee’s use of the premises for the purpose of producing  
25 marijuana, if the owner’s consent to the use of the premises is expired.”.

26 In line 37, after “section” insert “and, if the applicant or licensee is not  
27 the owner of the premises for which the license is being renewed, submit  
28 with the application the owner’s written signature, witnessed by a notary  
29 public, confirming ownership of the premises and consenting to the  
30 applicant’s or licensee’s use of the premises for the purpose of processing

1 marijuana, if the owner's consent to the use of the premises is expired".

2 On page 7, delete lines 29 through 45.

3 On page 8, delete line 1 and insert:

4 "(3) If the applicant described in subsection (1) of this section is not the  
5 owner of the premises to be registered under ORS 475C.792 or 475C.815, the  
6 applicant shall:

7 "(a) Inform the owner in writing that the premises is intended to be reg-  
8 istered under ORS 475C.792 or 475C.815;

9 "(b) If the owner wishes to consent to the use of the premises for the  
10 purpose of a marijuana grow site or marijuana processing site, obtain from  
11 the owner the owner's written signature, witnessed by a notary public, con-  
12 firming ownership of the premises and consenting to the applicant's use of  
13 the premises for the purpose of a marijuana grow site or marijuana pro-  
14 cessing site; and

15 "(c) Provide the owner's witnessed signature as described in paragraph (b)  
16 of this subsection to the authority.

17 "(4) An owner who consents as described in subsection (3) of this section  
18 to the use of the owner's premises for the purpose of a marijuana grow site  
19 or marijuana processing site may specify in the document that contains the  
20 owner's witnessed signature the number of annual licensure terms for which  
21 the owner's consent to the use of the premises is valid.

22 "(5) The authority shall cancel an application for a registration under  
23 ORS 475C.792 or 475C.815 if the authority:

24 "(a) Is not able to verify ownership of the premises described in sub-  
25 section (1) of this section; or

26 "(b) Does not receive, if the application is from an applicant described in  
27 subsection (3) of this section, the witnessed signature described in subsection  
28 (3) of this section.

29 "(6) The authority may adopt rules to carry out this section. Rules  
30 adopted under this section may include rules to establish a form for the

purposes of this section.”.

On page 9, after line 33, insert:

“(12) When submitting an application for renewal of registration under this section, the applicant or person responsible for the marijuana grow site shall, if the applicant or person is not the owner of the premises for which the registration is being renewed, submit with the application the owner’s written signature, witnessed by a notary public, confirming ownership of the premises and consenting to the applicant’s or person’s use of the premises for the purpose of a marijuana grow site, if the owner’s consent to the use of the premises is expired.”.

On page 11, line 7, after “site” insert “and, if the applicant or individual responsible for a marijuana processing site is not the owner of the premises for which the registration is being renewed, submit with the application for renewal the owner’s written signature, witnessed by a notary public, confirming ownership of the premises and consenting to the applicant’s or individual’s use of the premises for the purpose of a marijuana processing site, if the owner’s consent to the use of the premises is expired”.

After line 13, insert:

**“SECTION 14. Sections 2, 6 and 11 of this 2025 Act and the amendments to ORS 475A.250, 475A.290, 475C.037, 475C.065, 475C.085, 475C.792 and 475C.815 by sections 3, 4, 7, 8, 9, 12 and 13 of this 2025 Act apply to licenses or registrations issued or renewed on or after the operative date specified in section 15 of this 2025 Act.”.**

In line 14, delete “14” and insert “15”.

In line 24, delete “15” and insert “16”.
