- 4 **"SECTION 2.** ORS 813.270 is amended to read:
- 5 "813.270. The Intoxicated Driver Program Fund is created to consist of
- 6 moneys placed in the fund under ORS 813.030 and 813.240 or as otherwise
- 7 provided by law and of gifts and grants made to the fund for carrying out
- 8 the purposes of the fund. The moneys in the fund may be used only for the
- 9 following purposes:
- "(1) To pay for providing treatment for individuals who enter diversion
- 11 agreements under ORS 813.200 and who are found to be indigent. Payment
- 12 for treatment under this subsection may include treatment for problem
- drinking, alcoholism or drug dependency. Payment shall be made as provided
- by the Director of the Oregon Health Authority by rule to agencies or or-
- 15 ganizations providing treatment.
- 16 "(2) To pay for evaluation as provided by law of programs used for di-
- 17 version agreements.
- 18 "(3) To pay the cost of administration of the fund by the Oregon Health
- 19 Authority.
- 20 "(4) To pay for materials, resources and training supplied by the authority
- to those persons, organizations or agencies performing the screening inter-

- 3 "(5) To pay for providing treatment programs required under ORS 813.020
- 4 and treatment or information programs required under ORS 471.432 for in-
- 5 dividuals who are found to be indigent.
- 6 "(6) To pay for special services required to enable a person with a disa-
- 7 bility, or a person whose proficiency in the use of English is limited because
- 8 of the person's national origin, to participate in treatment programs that are
- 9 used for diversion agreements under ORS 813.200 or are required under ORS
- 10 813.020. This subsection applies:
- "(a) Whether or not the person is indigent; and
- "(b) Only to special services required solely because of the person's disa-
- bility or limited proficiency in the use of English.
 - "(7) To pay for screening interviews, the agency or organization
- 15 conducting the screening interviews and driving while under the in-
- 16 fluence of intoxicants education programs for indigent defendants.
 - **"SECTION 3.** ORS 813.233 is amended to read:
- 18 "813.233. In lieu of completing a treatment program in this state as a part
- 19 of completing the conditions of a driving while under the influence of
- 20 intoxicants diversion agreement in this state, the court may allow [a de-
- 21 fendant who is a member of the Armed Forces of the United States, the reserve
- 22 components of the Armed Forces of the United States or the National Guard
- 23 and who is serving on active duty] the following defendants to participate
- 24 in a comparable treatment program conducted by or authorized by a gov-
- 25 ernment entity in another jurisdiction[.]:
- 26 "(1) An individual who is not a resident of Oregon.
- 27 "(2) A member of the Armed Forces of the United States, the re-
- 28 serve components of the Armed Forces of the United States or the
- 29 National Guard and who is serving on active duty.".
