"SECTION 35. Section 36 of this 2025 Act is added to and made a
 part of ORS 691.405 to 691.485.

"SECTION 36. (1) Notwithstanding ORS 691.405 to 691.485, a person 20licensed by the Board of Licensed Dietitians and Nutritionists before 21the effective date of this 2025 Act, and a person whose application for 22licensure by the board was received by the board before the effective 23date of this 2025 Act, shall remain licensed, eligible for licensure re-24activation or eligible for licensure subject to the requirements in effect 25at the time of initial licensure or application for licensure, if the per-26son remains in good standing and, if the person is a licensee, main-27tains an active or inactive license. 28

29 "(2) Notwithstanding ORS 691.405 to 691.485, the board shall con-30 tinue to license as a dietitian a person licensed by the board as a

dietitian on or before the effective date of this 2025 Act, and may not 1 require the person to meet any additional requirements for licensure, $\mathbf{2}$ if the person holds a registered dietitian credential issued by the 3 Commission on Dietetic Registration, or its successor organization, as 4 approved by the board.
