PROPOSED AMENDMENTS TO HOUSE BILL 3552

1 On page 1 of the printed bill, delete lines 5 through 28.

2 On page 2, delete lines 1 through 12 and insert:

3 "SECTION 2. (1) Education service districts may establish regional 4 career centers to provide regional career and technical education 5 support and coordination. A regional career center may be jointly es-6 tablished with one or more community colleges within the region 7 served by the education service district.

8 "(2) The purposes of a regional career center are to:

"(b) The advisory committee must consist of the following repre sentatives of the region:

"(A) One representative from each community college within the
 region served by the education service district;

"(B) One representative from a regional network that supports sci ence, technology, engineering and mathematics;

"(C) One representative from each local and regional industry co ordinator located within the education service district;

"(E) One representative of a local workforce development board, as
 defined in ORS 660.300; and

"(F) Five representatives of regional industries or workforce devel opment providers.

2 "(C) Ensure that industry workforce needs are considered and that 3 the curriculum is kept current with state standards; and

4 "(D) Increase opportunities for internships, apprenticeships and

6 "(d) The advisory committee must meet at least once each month.

"(4) Based on rules adopted by the State Board of Education, the
Department of Education shall award grants to no more than 12 education service districts for a regional career center from moneys
available for regional career centers.

"(5) Each education service district that has a regional career cen ter shall provide an annual report to the Department of Education
 that identifies, for the region served by the education service district:
 "(a) The number of students who completed a career and technical

25 "<u>SECTION 4.</u> In addition to and not in lieu of any other appropri-26 ation, there is appropriated to the Department of Education, for the 27 biennium beginning July 1, 2025, out of the General Fund, the amount 28 of \$3,600,000, which may be expended for the purpose of supporting 29 regional career centers as provided by section 2 of this 2025 Act.".
