**PROPOSED AMENDMENTS TO
SENATE BILL 149**

1 In line 2 of the printed bill, after “immigration” insert “; amending ORS
2 411.139”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1.** ORS 411.139 is amended to read:

5 “411.139. (1) As used in this section:

6 “(a) ‘Eligible [*agency*] **entity**’ means:

7 **“(A) An [*agency*] entity that has, or previously had,** contracted with the
8 United States Department of State under 8 U.S.C. [*1522(c)*] **1522(b) or (c)** to
9 provide initial resettlement and case management services to refugees.

10 **“(B) A culturally responsive or specific organization that is designed**
11 **to effectively meet the needs of individuals from diverse cultural**
12 **backgrounds and experiences through an understanding and respect**
13 **for the beliefs, practices, culture and linguistic needs of the diverse**
14 **populations and communities that the entity serves.**

15 “(b) ‘Refugee’ means an individual who is not a United States citizen, who
16 has been in the United States for 60 months or less and who is **or has been**
17 any of the following:

18 “(A) A refugee admitted under 8 U.S.C. 1157.

19 “(B) An asylee admitted under 8 U.S.C. 1158.

20 “(C) A Cuban or Haitian entrant as defined in 45 C.F.R. 401.2.

21 “(D) A parolee admitted under 8 U.S.C. 1182(d)(5).

1 “(E) An Amerasian immigrant lawfully admitted to the United States who
2 is described in 8 U.S.C. 1612(a)(2)(A)(v).

3 “(F) A victim of a severe form of trafficking in persons and the victim’s
4 family members who are eligible for benefits and services from federal and
5 state programs under 22 U.S.C. 7105(b)(1)(A).

6 “(G) An Iraqi or an Afghan citizen who is a principal noncitizen provided
7 with the status of special immigrant by the United States Department of
8 Homeland Security under:

9 “(i) Section 1059(a) of the National Defense Authorization Act for Fiscal
10 Year 2006, P.L. 109-163, 119 Stat. 3444;

11 “(ii) Section 1244(b) of the Refugee Crisis in Iraq Act of 2007, P.L. 110-181,
12 122 Stat. 397; or

13 “(iii) Section 602(b) of the Afghan Allies Protection Act of 2009, P.L.
14 111-8, 123 Stat. 807.

15 “(H) **An individual who:**

16 “(i) **Is pursuing immigration assistance;**

17 “(ii) **Is not receiving support services under an eligible immigration**
18 **status designated by the federal Office of Refugee Resettlement; and**

19 “(iii) **Has been residing in this state for 24 months or less.**

20 “(2) The Department of Human Services shall award [*grants*] **contracts**
21 to eligible [*agencies*] **entities** to provide the following services to refugees
22 residing in this state, for up to 24 months:

23 “(a) Assisting refugees with department programs by:

24 “(A) Referring refugees to the department [*within three days of the*
25 *refugee’s arrival in this state*];

26 “(B) Completing applications for assistance;

27 “(C) Transporting the refugee to the initial appointments with the de-
28 partment;

29 “(D) Providing to the department all necessary eligibility information
30 known to the eligible [*agency*] **entity**; and

1 “(E) Coordinating services of the department with other social service
2 [agencies] **entities**.

3 “(b) Assisting refugees with:

4 “(A) Navigating the health care and mental health systems, including
5 providing assistance in applying for medical assistance;

6 “(B) Accessing housing [*assistance*] and finding stable housing;

7 “(C) Setting up utilities and paying utility bills;

8 “(D) Issues with landlords;

9 “(E) Navigating legal or criminal issues including services for victims of
10 crime;

11 “(F) Accessing in-home services including parenting assistance, English
12 as a second language instruction, medical and psychosocial support; and

13 “(G) Navigating the culture of the United States.

14 “(c) Providing transportation to appointments.

15 “(d) Training refugees on using public transportation.

16 “(e) Providing immigration assistance and referrals.

17 “(f) Advocating on behalf of refugees regarding domestic violence, federal
18 laws and hate crimes.

19 “(g) Providing refugees with interpretation services and assistance with
20 access to language services.

21 “(h) Providing referrals for refugees to culturally specific support groups
22 and services, including religious organizations.

23 “(i) Pairing refugees with volunteers for English as a second language
24 training and ongoing language support.

25 “(j) Providing support to refugees in budgeting and achieving financial
26 literacy.

27 “(k) Identifying refugees’ employment skills and providing referrals to
28 employment skills training and other job support services.

29 “(L) Problem solving with refugees and assisting refugees with life skills
30 development.

1 “(m) Ensuring that refugees have access to psychosocial support and
2 emotional wellness education.

3 “(n) Coordinating medical services for refugees including referring to and
4 coordinating with [*agencies*] **entities** that determine eligibility for disability
5 benefits.

6 “(o) Providing family preservation services, legal services and social ser-
7 vice support for domestic violence and child welfare issues.

8 “(p) Assisting newly arrived refugee children in accessing services to
9 strengthen the children’s academic performance and successful integration
10 into the community.

11 “(q) Other services necessary to assist refugees in accessing programs
12 administered by the department.

13 **“(3) In addition to the services listed under subsection (2) of this**
14 **section, the department shall award contracts to eligible entities to**
15 **provide immigration assistance and referrals to individuals who are**
16 **seeking a status listed under subsection (1)(b)(A) to (G) of this**
17 **section.”.**
