**PROPOSED AMENDMENTS TO  
HOUSE BILL 3342**

In line 2 of the printed bill, after “water” insert “; creating new provisions; and amending ORS 536.045, 536.410, 537.145, 537.147, 537.150, 537.153, 537.211, 537.225, 537.230, 537.252, 537.348, 537.409, 537.470, 537.610, 537.620, 537.621, 537.630, 538.450, 540.520, 540.524, 540.535, 540.570, 540.580, 540.585, 543.220, 543A.035, 543A.040, 543A.055 and 543A.120”.

Delete lines 4 through 8 and insert:

**“ELECTRONIC FORMS OF DOCUMENTS**

**“SECTION 1. ORS 536.045 is added to and made a part of ORS chapter 536.**

**“SECTION 2. ORS 536.045 is amended to read:**

**“536.045. (1) Notwithstanding any provision of ORS chapters 536 to 540, 543 or 543A that requires the mailing of a document, the submission of a document in written form or the provision of a certified copy of a document, the Water Resources [Department] Commission may adopt rules:**

**“(a) Allowing the submission of one or more types of document to the commission or the Water Resources Department by electronic means in lieu of submission by mailing or submission in written form;**

**“(b) [Allowing the department, with the consent of the recipient, to] Allowing the department or commission to send one or more types of doc-**

1 ument in electronic form in lieu of mailing or other sending of the document  
2 in written form, **unless the recipient has requested mailing or other**  
3 **sending of the document in written form; or**

4 “(c) Identifying acceptable means for verifying the authenticity of a doc-  
5 ument sent by electronic means in lieu of the provision of a certified copy  
6 of the document.

7 “(2) [*The department may not adopt rules to require the submission of*  
8 *documents to the department by electronic means. The department may not re-*  
9 *quire a recipient to consent to the receipt of documents from the department*  
10 *by electronic means.*] **Notwithstanding subsection (1) of this section**, the  
11 department **or commission** may not use electronic means in lieu of service  
12 under ORCP 7 or notice under ORS 183.413 or 183.415.

13 “(3) For purposes of determining timeliness or calculating deadlines, a  
14 document sent by electronic means in accordance with [*department*] **law or**  
15 **commission** rules is considered to be delivered when sent.

16 “(4) Notwithstanding any provision of ORS chapters 536 to 540, 543 or  
17 543A that specifies a fee amount, the department may reduce or waive the  
18 fee for a document that the department sends or receives by electronic  
19 means.

20 “(5) **To satisfy a requirement to provide public notice, the depart-**  
21 **ment may publish notice in a newspaper of general circulation. The**  
22 **cost of the publication shall be paid by the applicant in advance to the**  
23 **department.**

25 “**PUBLICATION IN A WEEKLY PUBLIC NOTICE**

26  
27 “**SECTION 3.** ORS 537.145 is amended to read:

28 “537.145. (1) If an application is made for a permit to appropriate water  
29 for hydroelectric purposes, the Water Resources Department shall give writ-  
30 ten notice of the filing of the application to the owner of any land that is:

1       “(a) Adjacent to any portion of the stream in which the quantity of water  
2 will be decreased by the project; or

3       “(b) Adjacent to the site of the proposed hydroelectric project.

4       “(2) The department shall also publish notice of the application [*once each*  
5 *week for at least two successive weeks and for such further time, if any, as the*  
6 *department shall determine, in a newspaper of general circulation in each*  
7 *county in which the project covered by the application is located*] **in the**  
8 **weekly public notice of the department.**

9       **“SECTION 4.** ORS 537.252 is amended to read:

10       “537.252. (1) When issuing a water right certificate under ORS 537.250 to  
11 a district, or to a government agency for a district, the Water Resources  
12 Department may issue the water right certificate for land not described in  
13 the permit if:

14       “(a) Water furnished by the district under the permit has been applied  
15 beneficially to the land;

16       “(b) The land not described in the permit that is proposed to be included  
17 in the certificate is included within the legally established boundaries of the  
18 district and is subject to the charges, assessments and liens of the district;

19       “(c) The certificate does not authorize a greater rate, duty or acreage  
20 than is authorized by the terms of the permit, and all other conditions of the  
21 permit are satisfied;

22       “(d) The inclusion of land not described in the permit will not result in  
23 injury to other existing water rights or in enlargement of the right author-  
24 ized under the permit; and

25       “(e) The impact to the water source of including land not described in the  
26 permit will not differ significantly from the impact expected at the time the  
27 permit was issued for the lands described in the permit.

28       “(2) If a district proposes to use water on lands not described in the per-  
29 mit, the Water Resources Department may issue a certificate that includes  
30 such additional lands if all of the conditions of subsection (1) of this section

1 are satisfied and if, no later than 60 days before the district actually applies  
2 the water to the lands not described in the permit, the district provides  
3 written notice to the department. The notice shall include a copy of the or-  
4 iginal permit map modified to show the lands to be added and lands to be  
5 removed from the description of the place of use of the water. Upon receipt  
6 of the notice from the district, the department shall provide public notice  
7 of the proposed change by means of publication in the department's weekly  
8 **public notice** *[notice and by publication once each week for two successive*  
9 *weeks in a newspaper having general circulation in the county or counties in*  
10 *which the affected lands are located. The cost of publication shall be paid by*  
11 *the district]*.

12 “(3) If a district has issued an order of inclusion or exclusion, the  
13 boundaries of the irrigation district shall be deemed to have been legally  
14 changed in the absence of approval of the Secretary of the Interior.

15 “(4) As used in this section:

16 “(a) ‘District’ has the meaning given in ORS 540.505.

17 “(b) ‘Legally established boundaries’ means the boundaries of a district  
18 as established at the time of creation of the district and as the boundaries  
19 may have changed after creation of the district by an inclusion, exclusion  
20 or merger proceeding according to state law.

21 **“SECTION 5.** ORS 540.520 is amended to read:

22 “540.520. (1)(a) Except when the application is made under ORS 541.327  
23 or when an application for a temporary transfer is made under ORS 540.523,  
24 if the holder of a water use subject to transfer for irrigation, domestic use,  
25 manufacturing purposes, or other use, for any reason desires to change the  
26 place of use, the point of diversion, or the use made of the water, an appli-  
27 cation to make such change, as the case may be, shall be filed with the  
28 Water Resources Department.

29 “(b) A holder of a water right certificate that authorizes the storage of  
30 water may change the type of use identified in the water right certificate,

1 as described in this section.

2 “(2) The application required under subsection (1) of this section shall  
3 include:

4 “(a) The name of the owner;

5 “(b) The previous use of the water;

6 “(c) A description of the premises upon which the water is used;

7 “(d) A description of the premises upon which it is proposed to use the  
8 water;

9 “(e) The use that is proposed to be made of the water;

10 “(f) The reasons for making the proposed change; and

11 “(g) Evidence that the water has been used over the past five years ac-  
12 cording to the terms and conditions of the owner’s water right certificate  
13 or that the water right is not subject to forfeiture under ORS 540.610.

14 “(3) If the application required under subsection (1) of this section is  
15 necessary to allow a change in a water right pursuant to ORS 537.348, is  
16 necessary to complete a project funded under ORS 541.932, or is approved by  
17 the State Department of Fish and Wildlife as a change that will result in a  
18 net benefit to fish and wildlife habitat, the **Water Resources** Department,  
19 at the discretion of the Water Resources Director, may waive or assist the  
20 applicant in satisfying the requirements of subsection (2)(c) and (d) of this  
21 section. The assistance provided by the department may include, but need  
22 not be limited to, development of an application map.

23 “(4) If the application is to change the point of diversion, the transfer  
24 shall include a condition that the holder of the water right provide a proper  
25 fish screen at the new point of diversion, if requested by the State Depart-  
26 ment of Fish and Wildlife.

27 “[5] *Upon the filing of the application the department shall give notice by*  
28 *publication in a newspaper having general circulation in the area in which the*  
29 *water rights are located, for a period of at least two weeks and not less than*  
30 *one publication each week. The notice shall include the date on which the last*

1 notice by publication will occur. The cost of the publication shall be paid by  
2 the applicant in advance to the department. In applications for only a change  
3 in place of use or for a change in the point of diversion of less than one-fourth  
4 mile, and where there are no intervening diversions between the old diversion  
5 of the applicant and the proposed new diversion, no newspaper notice need be  
6 published. The department shall include notice of such applications in the  
7 weekly notice published by the department.]

8 “[6] Within 30 days after the last publication of a newspaper notice of the  
9 proposed transfer or the mailing of the department’s weekly notice, whichever  
10 is later, any person may file, jointly or severally, with the department, a protest  
11 against approval of the application.]

12 **“(5) The Water Resources Department shall undertake an initial**  
13 **review of an application under subsection (1) of this section.**

14 **“(6)(a) Upon completion of the initial review, the department shall**  
15 **notify the applicant of its preliminary determinations, identify any**  
16 **outstanding information that is necessary to continue processing the**  
17 **application and allow the applicant 30 days from the date of notice to:**

18 **“(A) Notify the department to stop processing the application; or**

19 **“(B) Notify the department to continue processing the application**  
20 **and provide any outstanding information to the department.**

21 **“(b) If, within 30 days from the date of the notice, the applicant**  
22 **does not notify the department as provided in paragraph (a) of this**  
23 **subsection, does not provide all outstanding information as provided**  
24 **in paragraph (a)(B) of this subsection or notifies the department to**  
25 **stop processing the application, the department shall close the file for**  
26 **the application and take no further action on the application. The de-**  
27 **partment may allow an applicant up to 60 additional days to provide**  
28 **outstanding information if the applicant requests additional time and**  
29 **the department determines that the applicant is undertaking reason-**  
30 **able efforts to provide the information in a timely manner to the de-**

1 **partment.**

2 **“(c) If, within 30 days from the date of the notice or an additional**  
3 **time period allowed under paragraph (b) of this subsection, the appli-**  
4 **cant notifies the department to proceed with the application and pro-**  
5 **vides any outstanding information necessary to continue processing**  
6 **the application, the department shall:**

7 **“(A) Proceed with processing the application.**

8 **“(B) Give notice of the initial review in the weekly public notice of**  
9 **the department and accept written public comments for 30 days.**

10 **“(7) Upon issuance of a proposed final order, the department shall**  
11 **give notice of the order in the weekly public notice of the department.**  
12 **If the department determines that more than five water rights would**  
13 **be injured as a result of the change proposed in an application under**  
14 **subsection (1) of this section, the department shall publish notice once**  
15 **each week for two consecutive weeks in a newspaper of general cir-**  
16 **culation in the area in which the water rights are located. The cost**  
17 **of the publication shall be paid by the applicant in advance to the de-**  
18 **partment.**

19 **“[(7)] (8) If a timely protest is filed, or in the opinion of the Water Re-**  
20 **sources Director a hearing is necessary to determine whether the proposed**  
21 **changes as described by the application would result in injury to existing**  
22 **water rights, the department shall hold a hearing on the matter. Notice and**  
23 **conduct of the hearing shall be under the provisions of ORS chapter 183,**  
24 **pertaining to contested cases, and shall be held in the area where the rights**  
25 **are located unless all parties and persons who filed a protest under this**  
26 **subsection stipulate otherwise. A hearing is not required if:**

27 **“(a) All issues in the contested case are resolved pursuant to a**  
28 **settlement;**

29 **“(b) The protest is withdrawn; or**

30 **“(c) The protestant defaults.**

1        “[8] (9) An application for a change of use under this section is not re-  
2        quired if the beneficial use authorized by the water use subject to transfer  
3        is irrigation and the owner of the water right uses the water for incidental  
4        agricultural, stock watering and other uses related to irrigation use, so long  
5        as there is no increase in the rate, duty, total acreage benefited or season  
6        of use.

7        “[9] (10) A water right transfer under subsection (1) of this section is  
8        not required for a general industrial use that was not included in a water  
9        right certificate issued for a specific industrial use if:

10       “(a) The quantity of water used for the general industrial use is not  
11       greater than the rate allowed in the original water right and not greater  
12       than the quantity of water diverted to satisfy the authorized specific use  
13       under the original water right;

14       “(b) The location where the water is to be used for general industrial use  
15       was owned by the holder of the original water right at the time the water  
16       right permit was issued; and

17       “(c) The person who makes the change in water use provides the following  
18       information to the Water Resources Department:

19       “(A) The name and mailing address of the person using water under the  
20       water right;

21       “(B) The water right certificate number;

22       “(C) A description of the location of the industrial facility owned by the  
23       holder of the original water right at the time the water right permit was  
24       issued; and

25       “(D) A description of the general industrial use to be made of the water  
26       after the change.

27       **“SECTION 6.** ORS 540.535 is amended to read:

28       “540.535. After receipt of an exchange application, the Water Resources  
29       Commission shall give notice of the application **in the weekly public notice**  
30       **of the Water Resources Department** *[by publishing notice of the applica-*



tion in a newspaper having general circulation in the area in which the water uses are located at least once each week for at least two successive weeks. The cost of providing the notice by publication shall be paid in advance by the applicant to the commission].

**“SECTION 7.** ORS 543.220 is amended to read:

“543.220. (1) If an application is made for a preliminary permit, after said application has been referred to hearing, the Water Resources Commission shall give written notice of the filing of the application to:

“(a) Any municipality or other person or corporation that, in the judgment of the commission, is likely to be interested in or affected by the proposed project; and

“(b) The owner of any land that is:

“(A) Adjacent to any portion of the stream in which the quantity of water will be decreased by the project; or

“(B) Adjacent to the site of the proposed project.

“(2) The commission shall also publish notice of the application [*once each week for at least two successive weeks and for such further time, if any, as the commission shall determine, in a newspaper of general circulation in each county in which the project covered by the application is located*] **in the weekly public notice of the Water Resources Department.**

“(3) No application for the appropriation or use of water for the development of 1,000 theoretical horsepower or more shall be granted until at least six months after the application for a preliminary permit has been filed.

## **“PASSING ON CREDIT CARD FEES**

**“SECTION 8.** Section 9 of this 2025 Act is added to and made a part of ORS chapter 536.

**“SECTION 9.** (1) The Water Resources Department may accept payments by debit or credit card for any products or services offered

1 by, or fees owed to, the department.

2 “(2) The department may add a nonrefundable fee to the amount  
3 of any payment made by debit or credit card in an amount reasonably  
4 calculated to offset the impact to the department of financial institu-  
5 tion fees related to debit or credit card transactions.

6  
7 “WITHDRAWAL OF WATERS FROM APPROPRIATION VIA RULE  
8

9 “**SECTION 10.** ORS 536.410 is amended to read:

10 “536.410. (1) When the Water Resources Commission determines that it is  
11 necessary to [*insure*] **ensure** compliance with the state water resources pol-  
12 icy or that it is otherwise necessary in the public interest to conserve the  
13 water resources of this state for the maximum beneficial use and control  
14 thereof that any unappropriated waters of this state, including unappropri-  
15 ated waters released from storage or impoundment into the natural flow of  
16 a stream for specified purposes, be withdrawn from appropriation for all or  
17 any uses including exempt uses under ORS 537.545, the commission, on behalf  
18 of the state, may [*issue an order of*] **adopt a rule establishing** withdrawal.

19 “(2) Prior to the [*issuance of the order of*] **adoption of the rule estab-**  
20 **lishing** withdrawal, the commission shall hold a public hearing on the ne-  
21 cessity for the withdrawal. Notice of the hearing shall be published in at  
22 least one issue each week for at least two consecutive weeks prior to the  
23 hearing in a newspaper of general circulation published in each county in  
24 which are located the waters proposed to be withdrawn.

25 “(3) The [*order of*] **rule establishing** withdrawal shall specify with  
26 particularity the waters withdrawn from appropriation, the uses for which  
27 the waters are withdrawn[, **and** the reason for the withdrawal [*and the du-*  
28 *ration of the withdrawal*]. The commission may [*modify or revoke the order*  
29 *at any time*] **amend or repeal the rule to modify or revoke the with-**  
30 **drawal.**

1 “[4] Copies of the order of withdrawal and notices of any modification or  
2 revocation of the order of withdrawal shall be filed in the Water Resources  
3 Department.]

4 “[5] (4) While the [order of] **rule establishing** withdrawal is in effect,  
5 **a person may not submit, and the Water Resources Department may**  
6 **not file or process, [no] an** application for:

7 **“(a)** A permit to appropriate the waters withdrawn for the uses specified  
8 in the [order and no application for] **rule; or**

9 **“(b)** A preliminary permit or license involving appropriations of such  
10 waters [shall be received for filing by the Water Resources Commission].

11 **“SECTION 11. (1) The amendments to ORS 536.410 by section 10 of**  
12 **this 2025 Act apply to withdrawals of waters from appropriation that**  
13 **occur on or after the operative date specified in section 48 of this 2025**  
14 **Act.**

15 **“(2) Withdrawals of waters from appropriation under ORS 536.410**  
16 **that are in effect on the operative date specified in section 48 of this**  
17 **2025 Act shall remain in effect unless the withdrawals are modified or**  
18 **revoked by the Water Resources Commission on or after the operative**  
19 **date specified in section 48 of this 2025 Act.**

20  
21 **“RETURNING APPLICATIONS THAT CANNOT BE APPROVED**

22  
23 **“SECTION 12. Section 13 of this 2025 Act is added to and made a**  
24 **part of ORS chapter 536.**

25 **“SECTION 13. The Water Resources Department shall publish,**  
26 **make publicly available and regularly update a list of restrictions**  
27 **where the source of water is:**

28 **“(1) Designated as a critical ground water area under ORS 537.730.**

29 **“(2) Subject to restrictions on allowed ground water uses by classi-**  
30 **fication under ORS 536.340.**

1       **“(3) Withdrawn from appropriation under ORS chapter 538 or by**  
2       **rule or order of the Water Resources Commission under ORS 536.410.**

3       **“SECTION 14.** ORS 537.150 is amended to read:

4       “537.150. (1)(a) Within 15 days after receiving an application, the Water  
5       Resources Department shall determine whether the application contains the  
6       information listed under ORS 537.140 (1) and is complete and not defective,  
7       including the payment of all [*fees*] **applicable fees or fee amounts** required  
8       under ORS 537.140 (5).

9       **“(b)** If the department determines that the application is incomplete or  
10      defective or that not all [*fees*] **applicable fees or fee amounts** have been  
11      paid, the department shall return the fees paid and the application.

12      “(2) Upon determining that an application contains the information listed  
13      under ORS 537.140 (1) and is complete and not defective, the department shall  
14      indorse on the application the date upon which the application was received  
15      at the department, which shall be the priority date for any water right issued  
16      in response to the application. All applications that comply with the pro-  
17      visions of law shall be recorded in a suitable book kept for that purpose.

18      “(3) If an application is complete and not defective, the department shall  
19      determine whether the proposed use is prohibited [*by ORS chapter 538*]  
20      **pursuant to a restriction under section 13 (3) of this 2025 Act, if the**  
21      **department has information sufficient to make the determination at**  
22      **the time of application intake.** If the proposed use is prohibited [*by ORS*  
23      *chapter 538*] **as described in this subsection,** the department shall [*reject*]  
24      **return** the application and [*return*] all **or a portion of the fees paid** to the  
25      applicant with an explanation of the [*statutory prohibition*] **reason for the**  
26      **return.**

27      “(4) If the proposed use is not prohibited [*by ORS chapter 538*] **under**  
28      **subsection (3) of this section,** the department shall undertake an initial  
29      review of the application and make a preliminary determination of:

30      “(a) Whether the proposed use is restricted or limited by statute or rule;

1 “(b) The extent to which water is available from the proposed source  
2 during the times and in the amounts requested; and

3 “(c) Any other issue the department identifies as a result of the initial  
4 review that may preclude approval of or restrict the proposed use.

5 “(5)(a) Upon completion of the initial review and no later than 30 days  
6 after determining an application to be complete and not defective as de-  
7 scribed in subsection (1) of this section, the department shall notify the ap-  
8 plicant of its preliminary determinations and allow the applicant [14] **90** days  
9 from the date of [mailing] **notice** within which to notify the department to  
10 stop processing the application or to proceed with the application.

11 “(b) If, **within 90 days from the date of the notice**, the applicant no-  
12 tifies the department to stop processing the application **or does not notify**  
13 **the department whether to proceed with processing the application**, the  
14 department shall *[return the application and all fees paid in excess of \$310.*  
15 *If the department receives no timely response from the applicant, the depart-*  
16 *ment shall proceed with the application.]* **close the file for the application**  
17 **and take no further action on the application.**

18 “(c) If, **within 90 days from the date of the notice**, the applicant  
19 **notifies the department to proceed with the application and pays any**  
20 **remaining portion of the applicable examination fees, as described in**  
21 **section 29 of this 2025 Act, the department shall:**

22 “(A) **Proceed with processing the application; and**

23 “(B) **Give notice of the initial review in the weekly public notice of**  
24 **the department and accept written public comments for 30 days. The**  
25 **notice must include a request for comments on the application and**  
26 **information pertaining to how an interested person may obtain future**  
27 **notices about the application and a copy of the proposed final order.**

28 “[6) *Within seven days after proceeding with the application under sub-*  
29 *section (5) of this section, the department shall give public notice of the ap-*  
30 *plication in the weekly notice published by the department. The notice shall*

1 *include a request for comments on the application and information pertaining*  
2 *to how an interested person may obtain future notices about the application*  
3 *and a copy of the proposed final order.]*

4 “[7)] (6) Within 30 days after the public notice under subsection [(6)] (5)  
5 of this section, any person interested in the application shall submit written  
6 comments to the department. Any person who asks to receive a copy of the  
7 department’s proposed final order shall submit to the department the fee re-  
8 quired under ORS 536.050 (1).

9 **“SECTION 15. (1) On and after the operative date specified in sec-**  
10 **tion 48 of this 2025 Act, the Water Resources Department shall return**  
11 **any pending application described in ORS 537.150 for which:**

12 **“(a) Receipt by the department occurred before the operative date**  
13 **specified in section 48 of this 2025 Act;**

14 **“(b) A proposed final order has not been issued before the operative**  
15 **date specified in section 48 of this 2025 Act; and**

16 **“(c) The proposed use of water is prohibited pursuant to a re-**  
17 **striction described in section 13 (3) of this 2025 Act that was in effect**  
18 **at the time the application was received.**

19 **“(2) The department shall return all or a portion of the fees paid**  
20 **for pending applications returned under subsection (1) of this section.**

21 **“SECTION 16. Section 15 of this 2025 Act is repealed on January 2,**  
22 **2050.**

23 **“SECTION 17. ORS 537.211 is amended to read:**

24 **“537.211. (1) The approval of an application referred to in ORS 537.140 or**  
25 **537.400 shall be set forth in a water right permit issued by the Water Re-**  
26 **sources Department. The permit shall specify the details of the authorized**  
27 **use and shall set forth any terms, limitations and conditions as the depart-**  
28 **ment considers appropriate including but not limited to any applicable con-**  
29 **dition required under ORS 537.289. A copy of the permit shall be filed as a**  
30 **public record in the department. The permit shall be mailed to the applicant,**

1 and upon receipt of the permit the permittee may proceed with the con-  
2 struction of the necessary works and may take all action required to apply  
3 the water to the designated beneficial use and to perfect the proposed ap-  
4 propriation.

5 “(2) Except as provided in subsection [(6)] (7) of this section, if an appli-  
6 cation under ORS 537.140 or 537.400 indicates that the applicant does not  
7 have written authorization or an easement permitting access to nonowned  
8 land crossed by the proposed ditch, canal or other work, the department may  
9 issue a final order approving the application if the approval includes a con-  
10 dition requiring the applicant to obtain such written authorization, or ease-  
11 ment or ownership of such land and to provide the department with a copy  
12 of the written authorization, easement or evidence of ownership.

13 “(3) If an application referred to in ORS 537.140 or 537.400 is rejected, the  
14 department shall enter a written order setting forth the reasons for the re-  
15 jection. The applicant shall take no action toward construction of the works  
16 or use of the water. The department shall mail a copy of the order to the  
17 applicant.

18 “(4) The holder of a water right permit may change the point of diversion,  
19 change the point of appropriation, change the point of diversion to allow the  
20 appropriation of ground water or use the water on land to which the right  
21 is not appurtenant if:

22 “(a) The use of water on land to which the right is not appurtenant, the  
23 change of point of diversion or the change in point of appropriation does not  
24 result in injury to an existing water right;

25 “(b) For a proposed change in the place of use of the water, the land on  
26 which the water is to be used is owned or controlled by the holder of the  
27 permit and is contiguous to the land to which the permit is appurtenant;

28 “(c) All other terms of the permit remain the same, including but not  
29 limited to the beneficial use for which the water is used and the number of  
30 acres to which water is applied;

1 “(d) Prior approval is obtained from the district if the water is trans-  
2 ported or conveyed by an irrigation district organized under ORS chapter  
3 545, a drainage district organized under ORS chapter 547, a water improve-  
4 ment district organized under ORS chapter 552, a water control district or-  
5 ganized under ORS chapter 553 or a district improvement company or a  
6 corporation organized under ORS chapter 554;

7 “(e) The holder of the permit provides written notice to the department  
8 at least 60 days before making any changes to the lands, point of diversion  
9 or point of appropriation described in the permit;

10 “[*(f)* *The holder of the permit complies with the publication requirements*  
11 *of ORS 540.520 (5), if applicable;*]

12 “[*(g)*] **(f)** Diversion is provided with a proper fish screen, if requested by  
13 the State Department of Fish and Wildlife; and

14 “[*(h)*] **(g)** For a request to transfer the point of diversion to allow the  
15 appropriation of ground water, the proposed change meets the standards set  
16 forth in ORS 540.531 (2) or (3).

17 **“(5) The Water Resources Department may deny a change in the**  
18 **point of appropriation under subsection (4) of this section if the pro-**  
19 **posed point of appropriation is for a source of ground water restricted**  
20 **under section 13 of this 2025 Act and the proposed use is subject to the**  
21 **restriction.**

22 “[*(5)*] **(6)** Notwithstanding the requirements of subsection (4)(b) of this  
23 section, the holder of a water right permit may change the place of use of  
24 all or any portion of water under the permit to land that is not contiguous  
25 to the land to which the permit is appurtenant if:

26 “(a) The change to noncontiguous land is in furtherance of mitigation or  
27 conservation efforts undertaken for the purposes of benefiting a species listed  
28 as sensitive, threatened or endangered under ORS 496.171 to 496.192 or the  
29 federal Endangered Species Act of 1973 (16 U.S.C. 1531 to 1544), as deter-  
30 mined by the listing agency; and



1 “(b) All other requirements of subsection (4) of this section are met.

2 “[6)] (7) For an application made by or on behalf of a public corporation,  
3 the department may issue a permit approving the application without re-  
4 quiring the applicant to obtain prior written authorization or an easement  
5 permitting access to nonowned lands affected by the proposed project. How-  
6 ever, nothing in this subsection shall be construed to allow any person to  
7 trespass on the lands of another person.

8 “[7)] (8) When the department receives notice under subsection (4)(e) of  
9 this section, the department shall publish the notice in the department’s  
10 weekly public notice of water right applications.

11 “[8)] (9) If the use of water under the permit is for operation of a mining  
12 operation as defined in ORS 517.952:

13 “(a) Review of the application and approval or denial of the application  
14 shall be coordinated with the consolidated application process under ORS  
15 517.952 to 517.989. However, such review and approval or denial shall take  
16 into consideration all policy considerations for the appropriation of water  
17 as set forth in this chapter and ORS chapter 536.

18 “(b) The permit may be issued for exploration under ORS 517.702 to  
19 517.740, but the permit shall be conditioned on the applicant’s compliance  
20 with the consolidated application process.

21 “(c) The permit shall include a condition that additional conditions may  
22 be added to the use of water when a water right certificate is issued, or when  
23 the use of water is changed pursuant to ORS 540.520 and 540.530 to use for  
24 a mine.

25 “[9)] (10) As used in this section, ‘contiguous’ includes land separated  
26 from the land to which a water right is appurtenant by roads, utility corri-  
27 dors, irrigation ditches or publicly owned rights of way.

28 **“SECTION 18.** ORS 537.409 is amended to read:

29 “537.409. (1) In lieu of the process set forth in ORS 537.140 to 537.211 for  
30 applying for a water right permit, an [*owner of a reservoir*] **applicant for a**

1 **reservoir permit** may submit an application to the Water Resources De-  
2 partment to issue a water right permit under ORS 537.211 or a certificate  
3 under ORS 537.250 according to the process set forth in this section if the  
4 reservoir:

5 “(a) Has a storage capacity of less than 9.2 acre-feet or a dam or  
6 impoundment structure less than 10 feet in height;

7 “(b) Does not injure any existing water right;

8 “(c) Does not pose a significant detrimental impact to existing fishery  
9 resources as determined on the basis of information submitted by the State  
10 Department of Fish and Wildlife; *[and]*

11 “(d) Is not prohibited under ORS 390.835[.]; **and**

12 **“(e) Is not prohibited under ORS chapter 538.**

13 “(2) An application for a water right permit for a reservoir under sub-  
14 section (1) of this section shall provide sufficient information to demonstrate  
15 compliance with the criteria set forth in subsection (1) of this section. The  
16 application shall:

17 “(a) Include the quantity of water to be stored by the reservoir, a map  
18 indicating the location of the reservoir and the source of the water used to  
19 fill the reservoir; and

20 “(b) Be accompanied by the fee established in ORS 536.050 (1)(q).

21 “(3) The map required under subsection (2) of this section need not be  
22 prepared by a water right examiner certified under ORS 537.798. The map  
23 submitted with the application shall comply with standards established by  
24 the Water Resources Commission.

25 “(4) Within 60 days after receiving an application under subsection (1) of  
26 this section, the Water Resources Department shall provide public notice of  
27 the application in the *[manner the department determines to be the most ap-  
28 propriate]* **weekly public notice of the department.**

29 “(5) Within 60 days after the department provides public notice under  
30 subsection (4) of this section, any person may submit detailed, legally ob-

1   tained information in writing, requesting the department to deny the appli-  
2   cation for a permit on the basis that the reservoir:

3       “(a) Would result in injury to an existing water right; or

4       “(b) Would pose a significant detrimental impact to existing fishery re-  
5   sources.

6       “(6) In accordance with rules established by the Water Resources Com-  
7   mission for an expedited public interest review process for applications sub-  
8   mitted under this section or in response to a request under subsection (5)  
9   of this section, the department shall conduct a public interest review of the  
10  reservoir application. The review shall be limited to issues pertaining to:

11       “(a) Water availability;

12       “(b) Potential detrimental impact to existing fishery resources; and

14       “(7) Within 180 days after the department receives an application for a

16  order granting or denying the permit or granting the permit with conditions.

16 “537.610. (1) The Water Resources Commission shall accept all registra-  
17 tion statements referred to in ORS 537.605 completed and returned to the  
18 commission in proper form, endorse on the registration statement the date  
19 of the return and record each statement. Upon recording the statement, the  
20 commission shall issue to the registrant a certificate as evidence that the  
21 registration is completed.

22 “(2) The issuance of the certificate of registration serves as prima facie

15 “537.620. (1) The Water Resources Department shall accept all applica-  
16 tions for permits submitted under ORS 537.615 in proper form.

17 “(2)(a) Within 15 days after receiving the application, the department  
18 shall determine whether the application contains the information listed un-  
19 der ORS 537.615 (2) and is complete and not defective, including the payment  
20 of all [*fees*] **applicable fees or fee amounts** required under ORS 537.615 (5).

21 “(b) If the department determines that the application is incomplete or  
22 defective or that not all **applicable fees or fee amounts** have been paid, the  
23 department shall return the fees paid and the application to the applicant  
24 [*to remedy the defect*].

25 “(c) If an application is complete and not defective, the department shall  
26 indorse on the application the date upon which the application was received  
27 at the department, which shall be the priority date for any water right issued  
28 in response to the application.

12 “(4) If the proposed use is not prohibited [*by statute*] **as described in**  
13 **subsection (3)(a) of this section,** the department shall undertake an initial  
14 review of the application and make a preliminary determination of:

15 “(a) Whether the proposed use is restricted or limited by statute or rule  
16 or because the proposed use is located within a designated critical ground  
17 water area;

18 “(b) The extent to which water is available from the proposed source  
19 during the times and in the amounts requested; and

27 and the maximum rate or duty diverted as of the later of:

28 “(a) June 29, 2005;

29 “(b) The time specified in the permit to perfect the water right; or

30 “(c) The time specified in the last-approved extension of time to perfect



1 the water right.

2 “(2) Except for a holder of a permit for municipal *[use]*, **quasi-municipal,**  
3 **group domestic or group domestic expanded uses**, the holder of a water  
4 right permit shall prosecute the construction of any proposed irrigation or  
5 other work with reasonable diligence and complete the construction within  
6 a reasonable time, as fixed in the permit by the Water Resources Depart-  
7 ment, not to exceed *[five]* **seven** years from the date of approval.

8 “(3) The holder of a permit for municipal use shall commence and com-  
9 plete the construction of any proposed works within 20 years from the date  
10 on which a permit for municipal use is issued under ORS 537.211. The con-  
11 struction must proceed with reasonable diligence and be completed within

17 “[4] (5) If the construction of any well or other means of developing and  
18 securing the ground water is completed after the date of approval of the  
19 application for a permit under ORS 537.625, within 30 days after the com-  
20 pletion, or if the construction is completed before the date of approval,  
21 within 30 days after the date of approval, the permit holder shall file a cer-  
22 tificate of completion with the Water Resources Department, disclosing:

23 “(a) The depth to the water table;

24 “(b) The depth, diameter and type of each well, and the kind and amount  
25 of the casing;

26 “(c) The capacity of the well pump in gallons per minute and the  
27 drawdown thereof;

28 “(d) The identity of the record owner of any property that was described  
29 in the application for a permit under ORS 537.625 but is not included in the  
30 certificate of completion; and

1 “(e) Any other information the department considers necessary.

2 “[5] **(6)** Upon completion of beneficial use necessary to secure the  
3 ground water as required under this section, the permit holder shall hire a  
4 water right examiner certified under ORS 537.798 to survey the appropri-  
5 ation. Within one year after applying the water to beneficial use or the  
6 beneficial use date allowed in the permit, the permit holder shall submit the  
7 survey as required by the Water Resources Department to the department  
8 along with the certificate of completion required under subsection (4) of this  
9 section. If any property described in the permit is not included in the request  
10 for a water right certificate, the holder of the permit shall state the identity

29 right, the holder of a permit shall have a facility capable of handling the full

“(b) The nonuse of water from the supplemental source occurred during a period of time within which the exercise of the supplemental water right permit was not necessary due to climatic conditions.

**“(a) Development timelines on new water right permits for which the proposed final order for the water right permit application is issued on or after the operative date specified in section 48 of this 2025 Act.**

**“(b) Extension applications submitted on or after the operative date specified in section 48 of this 2025 Act for permits for quasi-municipal, group domestic or group domestic expanded uses.**

**(2) Notwithstanding ORS 537.230 and 537.630, except for a holder of a permit for municipal, quasi-municipal, group domestic or group domestic expanded uses, the following applications for extensions on permits will be processed under subsection (3) of this section:**

2 “(3) The Water Resources Department shall, for good cause shown,

23           **“(b) A protest is not received by the department within the 33 days.**

27 to an in-stream water right under this section shall retain the priority date  
28 of the water right purchased, leased or received as a gift. At the request of  
29 the person the Water Resources Commission shall issue a new certificate for  
30 the in-stream water right showing the original priority date of the purchased,

1 gifted or leased water right. Except as provided in subsections (2) to (6) of  
2 this section, a person who transfers a water right by purchase, lease or gift  
3 under this subsection shall comply with the requirements for the transfer of  
4 a water right under ORS 540.505 to 540.585.

5 “(2) Subject to subsections (3) to (6) of this section, any person who has  
6 an existing water right may lease all or a portion of the existing water right  
7 for use as an in-stream water right for a specified period without the loss  
8 of the original priority date. During the term of the lease, the use of the  
9 water right as an in-stream water right shall be considered a beneficial use.  
10 The term of the lease may not exceed five years. The term of the lease may  
11 be renewed. There is no limitation on the number of times that the lease  
12 may be renewed.

13 “(3) A lease of all or a portion of an existing water right for use as an  
14 in-stream water right under subsection (2) of this section may allow the split  
15 use of the water between the existing water right and the in-stream water  
16 right during the same calendar year, provided:

17 “(a) The uses of the existing water right and the in-stream water right  
18 are not concurrent; and

19 “(b) The holders of the water rights measure and report to the Water  
20 Resources Department the use of the existing water right and the in-stream  
21 water right.

22 “(4) A person who has an existing water right and wishes to lease the  
23 water right as described in subsection (2) of this section must file a request  
24 and obtain department approval of the lease. Upon receipt of the request, the  
25 department shall provide notice of the request by inclusion in the weekly  
26 **public** notice published by the department. Any allegation of injury must be  
27 delivered to the department no later than 21 days after publication of the  
28 request in the weekly **public** notice.

29 “(5) After publishing notice of a request made under subsection (2) of this  
30 section and allowing time for the delivery of allegations of injury, the de-

partment shall issue an order approving the request if the department finds that the leasing of the water right for in-stream use can be effected without injury to other existing water rights or can be conditioned to prevent injury to other existing water rights. If the lease is for the split use of water between the existing water right and the in-stream water right during the same calendar year, the conditions imposed in the order approving the request must include, but need not be limited to, compliance with subsection (3) of this section.

“(6) The department at any time may revoke or modify an order issued for a lease under subsection (2) of this section if the department determines that the use of the water right for in-stream use under the lease has resulted in or may result in injury to an existing water right.

**“SECTION 37.** ORS 537.470 is amended to read:

“537.470. (1) Upon receipt of an application for allocation of conserved water under ORS 537.465, the Water Resources Commission shall give notice of receipt of the application in accordance with ORS 540.520 [(5)] **(6)(c)(B)**.

“(2) The commission shall allocate conserved water as provided in subsection (3) of this section and approve modifications of water rights as provided in subsection (6) of this section. The commission may not allocate conserved water pursuant to an application under ORS 537.465 if the application is filed more than five years after the conservation measure was implemented.

“(3) After determining the quantity of conserved water, if any, required to mitigate the effects on other water rights, the commission shall allocate 25 percent of the remaining conserved water to the state and 75 percent to the applicant, unless the applicant proposes a higher allocation to the state or more than 25 percent of the funds used to finance the conservation measures comes from federal or state public sources. 12 “(4) The commission shall notify the applicant and any other person re-  
13 questing notice, of the action the commission intends to take under sub-  
14 section (3) of this section. Any person objecting to the proposed allocation  
15 may file a protest requesting a contested case hearing before the commission.

16 “(5) The modification of water rights under an allocation of conserved  
17 water may not require a separate request for transfer under ORS 540.520.

18 “(6) After the commission completes the allocation of conserved water  
19 under subsection (3) of this section, the commission shall issue orders for  
20 proposed new certificates covering the changes in the original water rights.  
21 Once the conservation project is completed, separate new certificates pre-

1 ters of the north fork of the Umatilla River, the springs at the head which

6 “(2) The City of Pendleton, its water commission, any of the city’s agents,

8 waters for these purposes and uses for the benefit and use of the city, as  
9 above set forth, either by the city in its own name, or by any of its agents,  
10 agencies or officers or by any other persons on its behalf.

11 “(3) No person shall appropriate or be granted a permit to the use of any  
12 of such waters, except as provided in this section. But the City of Pendleton  
13 may, under this grant, divert such waters from their watershed and convey  
14 them to the city and elsewhere for use by it for public or municipal purposes

5 “(h) Any other information required by the department that is necessary  
6 to understand the nature of the proposed project.

7 “(6) Prior to submitting a notice of intent pursuant to subsection (5) of  
8 this section, the City of Pendleton shall hold a public meeting in the water  
9 basin in which the right is located to discuss the proposed project and re-  
10 ceive comments from the public.

11 “(7) Within 14 days after receiving a notice of intent submitted pursuant  
12 to subsection (5) of this section, the department shall, in the weekly **public**  
13 notice published by the department, give public notice of the submission of  
14 the notice of intent.

15 “(8) The Confederated Tribes of the Umatilla Indian Reservation and the  
16 City of Pendleton have entered into an agreement addressing the develop-  
17 ment and use of the City of Pendleton’s water rights in the Umatilla River  
18 and the impact on tribal interests from such development. The agreement  
19 includes implementation of the minimum streamflow in the main stem of the

28 “**SECTION 39.** ORS 540.524 is amended to read:

29 “540.524. (1) Notwithstanding ORS 540.510 or 540.670, upon approval of an  
30 application submitted to the Water Resources Department, the holder of both

1 a primary water right originating from a surface water source and a sup-  
2 plemental water right permit or certificate originating from a ground water  
3 source may substitute the use of the supplemental water right for the pri-  
4 mary water right. A substitution may not be made under this subsection if  
5 the use of the supplemental water right results in an enlargement or expan-

“(7) Upon expiration of the temporary transfer period, all uses of water for which a temporary transfer is allowed under this section shall revert automatically to the terms and conditions of the original water right permit, certificate or adjudication under ORS chapter 539 as evidenced by a court decree.

“(8) The time during which water is used under an approved temporary transfer order does not apply toward a finding of forfeiture under ORS 540.610.

**“SECTION 41.** ORS 540.580 is amended to read:

“540.580. (1) In accordance with this section, a district may by petition request that the Water Resources Department approve the permanent transfer of the place of use of water within a district as long as the proposed transfer complies with all of the following:

“(a) The rate, duty and total number of acres to which water is to be applied under the water use subject to transfer are not exceeded;

“(b) The use authorized under the water use subject to transfer remains the same;

“(c) The change in place of use will not result in injury to any existing water right; and

1       “(d) The land from which the water right is removed by the transfer shall  
2 receive no water under the transferred right.

3       “(2) A district may submit a petition for a permanent transfer prior to  
4 or subsequent to the change in place of use, but no later than the end of the

3 “543A.035. (1) Within 60 days after submitting a notice of intent under

7 “(2) The reauthorization application for a water right for the use of water  
8 for hydroelectric purposes shall set forth:

2 about the state project and may submit written comments to the department.

3 **“SECTION 44.** ORS 543A.040 is amended to read:

4 “543A.040. (1) Within 60 days after the close of the period allowed for  
5 public comment under ORS 543A.035, the Hydroelectric Application Review  
6 Team shall determine whether the reauthorization application for the water  
7 right contains sufficient information to determine whether reauthorization  
8 of the state project will comply with ORS 543A.025.

9 “(2) If the team decides that sufficient information is available to deter-  
10 mine whether reauthorization of the water right for the state project will  
11 comply with ORS 543A.025, the team shall proceed with expedited processing  
12 of the reauthorization application. The team shall review the application and  
13 any public comments received on the application and prepare a draft pro-  
14 posed final order, including findings of fact and conclusions of law, for the  
15 water right. Upon completion of the draft proposed final order, the team  
16 shall give public notice of the draft proposed final order in the weekly **public**  
17 notice published by the Water Resources Department. The notice shall in-  
18 clude a request for comments on the draft proposed final order.

19 “(3) Within 60 days after the public notice under subsection (2) of this  
20 section, any person interested in the draft proposed final order shall submit  
21 written comments to the team. A person who submits written comments un-  
22 der this subsection shall identify the provision of the draft proposed final  
23 order in question and specify why the person objects to or supports the  
24 provision. The team shall review the comments received and may revise the  
25 draft proposed final order. Unless the department receives a request under  
26 subsection (4) of this section, the team shall submit a proposed final order  
27 to the department within 30 days after the close of the period for public  
28 comment on the draft proposed final order.

29 “(4) If the draft proposed final order prepared by the team under sub-  
30 section (2) of this section proposes to deny the application for reauthori-

1 zation of the water right, the applicant may request the department to  
2 process the application in accordance with ORS 543A.045 to 543A.055. The  
3 applicant shall submit a request under this subsection within the 60-day pe-  
4 riod allowed for public comment on the draft proposed final order.

5 “(5) Unless the department receives a request under subsection (4) of this  
6 section, the department shall issue the proposed final order in accordance  
7 with the provisions of ORS 543A.120 to 543A.300.

8 “(6) If the team determines that additional information is necessary to  
9 determine whether reauthorization of the state project will comply with ORS  
10 543A.025, the applicant shall comply with the process established in ORS  
11 543A.045 to 543A.055 and 543A.120 to 543A.300.

12 **“SECTION 45.** ORS 543A.055 is amended to read:

13 “543A.055. (1) The Hydroelectric Application Review Team shall review  
14 the application report prepared under ORS 543A.050 and prepare a draft  
15 proposed final order approving or denying the reauthorization of the water  
16 right. The draft proposed final order shall include the findings required for  
17 a proposed final order under ORS 543A.120. Upon completion of the draft  
18 proposed final order, the Water Resources Department shall give public no-  
19 tice of the draft proposed final order in the weekly **public** notice published  
20 by the department. The notice shall include a request for comments on the  
21 draft proposed final order.

22 “(2) Within 60 days after the public notice under subsection (1) of this  
23 section, any person interested in the draft proposed final order shall submit  
24 written comments to the team.

25 “(3) Within 30 days after the close of the period for public comment on  
26 the draft proposed final order, the team shall make any revisions necessary  
27 in response to comments received and submit a proposed final order to the  
28 department.

29 “(4) The department shall complete the reauthorization process in ac-  
30 cordance with the provisions of ORS 543A.120 to 543A.300.

1       **“SECTION 46.** ORS 543A.120 is amended to read:

2       “543A.120. (1) A proposed final order prepared by a Hydroelectric Appli-  
3 cation Review Team and submitted to the Water Resources Department un-  
4 der ORS 543A.040, 543A.055 or 543A.105 shall be based on the application of  
5 the standards set forth in ORS 543A.025 and shall reflect the complete review  
6 of the water right application for compliance with applicable statutes and  
7 rules.

8       “(2) The proposed final order shall cite findings of fact and conclusions  
9 of law and shall include but need not be limited to:

10      “(a) Confirmation or modification of the preliminary determinations made  
11 in the initial review;

12      “(b) A brief statement that explains the criteria considered relevant to the  
13 decision, including the applicable basin program, the compatibility of the  
14 proposed use with applicable land use plans and information set forth in the  
15 application report or final report on studies;

16      “(c) An assessment of water availability and the amount of water neces-  
17 sary for the proposed use;

18      “(d) An assessment of whether the proposed use would result in injury to  
19 existing water rights;

20      “(e) An assessment of whether the proposed use would impair or be det-  
21 rimental to the public interest as provided in ORS 543A.025;

22      “(f) A draft certificate, including any proposed conditions, or a recom-  
23 mendation to deny the application; and

24      “(g) The date by which protests to the proposed final order must be re-  
25 ceived by the department.

26      “(3) The department shall mail copies of the proposed final order, as  
27 submitted by the team, to the applicant and to persons who have requested  
28 copies and paid the fee required under ORS 536.050 (1)(p). The department  
29 also shall give public notice of the proposed final order in the weekly **public**  
30 notice published by the department.

1 “(4) Any person may request standing for purposes of participating in any  
2 contested case proceeding on the proposed final order or for judicial review  
3 of a final order. A request for standing shall be in writing and shall be ac-  
4 companied by the fee established under ORS 536.050 (1)(n).

5 “(5) Any person may submit a protest against a proposed final order. A  
6 protest shall be in writing and shall include:

7 “(a) The name, address and telephone number of the protestant;

8 “(b) A description of the protestant’s interest in the proposed final order  
9 and, if the protestant claims to represent the public interest, a precise  
10 statement of the public interest represented;

11 “(c) A detailed description of how the action proposed in the proposed  
12 final order would impair or be detrimental to the protestant’s interest;

13 “(d) A detailed description of how the proposed final order is in error or  
14 deficient and how to correct the alleged error or deficiency;

15 “(e) Any citation of legal authority supporting the protest, if known; and

16 “(f) The protest fee required under ORS 536.050 (1)(j).

17 “(6) Requests for standing and protests on the proposed final order shall  
18 be submitted within 45 days after publication of the notice of the proposed  
19 final order in the weekly **public** notice published by the department. Any  
20 person who asks to receive a copy of the department’s final order shall sub-  
21 mit to the department the fee required under ORS 536.050 (1)(p), unless the  
22 person has previously requested copies and paid the required fee.

23 “(7) The Hydroelectric Application Review Team shall review any protest  
24 received and provide to the Water Resources Director a recommended re-  
25 sponse to any protest received.

26 “(8) Within 120 days after the close of the period for receiving protests  
27 and after consultation with the Hydroelectric Application Review Team, the  
28 director shall:

29 “(a) Issue a final order as provided under ORS 543A.130; or

30 “(b) Schedule a contested case hearing if a protest has been submitted and



1 if:

2 “(A) Upon review of the issues, the director finds that there are signif-  
3 icant disputes related to the proposed reauthorization of the project; or

4 “(B) Within 30 days after the close of the period for submitting protests,  
5 the applicant requests a contested case hearing.

6 “(9) At the request of the applicant, the department may extend the time  
7 periods set forth in subsection (8) of this section for a reasonable period of  
8 time.

9 “(10) If the application is for reauthorization of a water right for a  
10 federally licensed project, the department may postpone the issuance of the  
11 final order until the Federal Energy Regulatory Commission license is is-  
12 sued.

16 **“SECTION 47. The unit captions used in this 2025 Act are provided**  
17 **only for the convenience of the reader and do not become part of the**  
18 **statutory law of this state or express any legislative intent in the**  
19 **enactment of this 2025 Act.**

23 **“SECTION 48. Sections 9, 13, 24, 29 and 31a of this 2025 Act and the**

3       **“SECTION 49. The Water Resources Department and the Water**  
4 **Resources Commission may take any action before the operative date**  
5 **specified in section 48 of this 2025 Act that is necessary to enable the**  
6 **department and the commission to exercise, on and after the operative**  
7 **date specified in section 48 of this 2025 Act, all of the duties, functions**  
8 **and powers conferred on the department and the commission by the**  
9 **provisions of this 2025 Act.**
