# PROPOSED AMENDMENTS TO HOUSE BILL 2845

On page 1 of the printed bill, line 2, after "provisions;" delete the rest 1 of the line and insert "amending ORS 192.390, 406.020, 406.140, 406.462, 2 408.115 and 408.425; and declaring an emergency.". 3 Delete lines 4 through 22 and delete pages 2 through 5 and insert: 4 "SECTION 1. This 2025 Act shall be known and may be cited as the 5 2025 Oregon Veterans' Services Supplemental Investments Initiative. 6 7 **"FUNDING GOAL** 8 9 "SECTION 2. It is the goal of the Legislative Assembly to fund the 10 Department of Veterans' Affairs at a level that is no less than 11 \$10,000,000, from the General Fund, as measured in 2015 and adjusted 12 for inflation as calculated by the Legislative Fiscal Office. 13 14 **"ADDITIONAL STAFF POSITIONS** 1516 "SECTION 3. (1) No later than the dates specified in subsections (2), 17 (3) and (4) of this section, the Director of Veterans' Affairs shall es-18 tablish, hire for and staff within the Department of Veterans' Affairs 19 the following additional full-time equivalent positions: 20 "(a) Two coordinators for incarcerated veterans. 21

- 1 "(b) One women veterans coordinator
- 2 "(c) One addiction services coordinator.
- 3 "(d) One behavioral health coordinator.
- 4 "(e) One state approving agency staff.
- 5 "(f) Two coordinators for houseless veterans.
- 6 "(g) Two financial recovery ombudspersons.

7 "(h) One bridge grant support coordinator.

8 "(i) One veterans employment coordinator.

9 "(2) The director shall establish, hire for and staff four of the posi10 tions listed in subsection (1) of this section no later than July 1, 2026.
11 Three of the positions must be:

- 12 "(a) One coordinator for incarcerated veterans.
- 13 **"(b) One addiction services coordinator.**
- 14 "(c) One veterans employment coordinator.

"(3) The director shall establish, hire for and staff four of the remaining positions listed in subsection (1) of this section no later than
July 1, 2027.

"(4) The director shall establish, hire for and staff the four re maining positions listed in subsection (1) of this section no later than
 July 1, 2028.

"<u>SECTION 4.</u> The position of Veterans Employment Coordinator is
 created in the Department of Veterans' Affairs. The responsibilities
 of the coordinator include, but are not limited to, all of the following:
 "(1) Assisting veterans with finding employment.

25 "(2) Providing veterans with career and job resources.

26 "(3) Serving as a liaison between the Department of Veterans' Af-27 fairs and county veterans' service officers.

"(4) Contacting any service member who separates from the Oregon
National Guard within two weeks from the date of separation.

30 "(5) Contacting any service member who separates from the Armed

Forces of the United States and who resides in or is moving into this state within two weeks from the date the coordinator is informed of the service member separating and residing in or moving into this state.

- **"DIRECTOR AND DEPUTY DIRECTOR**
- 8 "SECTION 5. ORS 406.020 is amended to read:

"406.020. The Department of Veterans' Affairs shall be under the super-9 vision and control of the Director of Veterans' Affairs. The Governor shall 10 appoint the director subject to confirmation by the Senate in the manner 11 provided in ORS 171.562 and 171.565. The appointment may not be made 12 without the written approval of the Advisory Committee provided for in ORS 13 406.210. The director shall be a veteran[,] who received a discharge or 14 release under other than dishonorable conditions, chosen on the basis 15of executive and administrative ability. 16

17 "SECTION 6. The Director of Veterans' Affairs, subject to approval 18 by the Governor, may appoint a deputy director. In appointing a dep-19 uty director, the director shall consider the experience that a veteran 20 may bring if a veteran is appointed to the position. The deputy director 21 serves at the pleasure of the director, has full authority to act for the 22 director and is subject to the control of the director.

# **"VETERANS SUICIDE PREVENTION PILOT PROGRAMS**

25

"<u>SECTION 7.</u> (1) As used in this section, 'veteran' has the meaning
given that term in ORS 408.225. 'Veteran' includes a disabled veteran
as defined in ORS 408.225.

"(2) The Department of Veterans' Affairs shall develop and imple ment one or more pilot programs for suicide prevention and workforce

preparation. The purpose of the pilot programs is to help veterans with
suicide prevention and transition to the workforce and business community.

"(3) The department shall implement the pilot programs under this
section by awarding grants through a request for proposal process to:
"(a) Entities involved in pairing suicide prevention and housing
with workforce training and preparation in the agriculture, fishery,
forestry or natural resources industries;

9 "(b) Entities that provide temporary, low-barrier suicide prevention
 10 programs; and

11 "(c) Courtney Place Veterans Housing.

12 **"(4) The department shall:** 

"(a) Develop criteria for entities that provide programs for suicide
 prevention and workforce training and preparation;

"(b) By rule, establish processes and procedures for veterans to ap ply for assistance from entities identified in subsection (3) of this sec tion; and

"(c) Prioritize awarding grants to entities that provide opportunities
 for veterans to participate in the veterans' local communities.

"(5) The department may solicit and accept gifts, grants and do nations from public and private sources to further the purposes of this
 section.

"(6)(a) The department may use moneys in the Veterans' Services
Fund established pursuant to Article XV, section 4f, of the Oregon
Constitution, to develop, implement and maintain the pilot programs
under this section.

"(b) The department shall use moneys in the Veterans' Services
Fund established pursuant to Article XV, section 4f, of the Oregon
Constitution, for the initial moneys used to develop, implement and
maintain the pilot programs under this section.

"(7) The department may adopt rules to implement the provisions
of this section.

3 "SECTION 8. Not later than January 2, 2027, the Department of 4 Veterans' Affairs shall prepare and submit a report to the interim 5 committees of the Legislative Assembly related to veterans on the 6 status of pilot programs developed and implemented under section 7 7 of this 2025 Act.

8 "SECTION 9. (1) Section 7 of this 2025 Act is repealed on January
9 2, 2028.

10 "(2) All moneys for the pilot programs developed and implemented 11 under section 7 of this 2025 Act that are unexpended and unobligated 12 on the date of the repeal of section 7 of this 2025 Act shall revert to 13 the Veterans' Services Fund and become available for use pursuant to 14 Article XV, section 4f, of the Oregon Constitution.

#### **"VETERANS' SERVICES FUND**

18 **"SECTION 10.** ORS 406.140 is amended to read:

"406.140. There is established in the State Treasury, separate and distinct 19 from the General Fund, the Veterans' Services Fund, to be administered by 20the Oregon Department of Administrative Services. Interest earned by the 21fund is credited to the fund. Pursuant to Article XV, section 4f, of the 22Oregon Constitution, one and one-half percent of the net proceeds from the 23Oregon State Lottery shall be deposited in the Veterans' Services Fund. All 24moneys transferred from the State Lottery Fund and all other moneys au-25thorized to be transferred to the Veterans' Services Fund from whatever 26source are appropriated continuously to provide services for the benefit of 27veterans. The department shall hold no more than 12 percent of the 28fund in reserve. 29

#### **"COUNTY VETERANS' SERVICE OFFICER PROGRAM**

"<u>SECTION 11.</u> ORS 406.462 is amended to read:

"406.462. (1) Moneys appropriated to the Director of Veterans' Affairs for
the purposes described in ORS 406.450 must be distributed to county governing bodies and expended for the purposes of ORS 406.450 and may not be
used to supplant moneys currently budgeted by the director for services
provided by county veterans' service officers.

9 "(2) The director shall distribute moneys appropriated to the direc10 tor for the purposes described in ORS 406.450 on a quarterly basis as
11 follows:

"(a) Each fiscal year, the director shall notify each county govern ing body of the amount of moneys to be distributed to the county
 governing body for the fiscal year.

"(b) The county governing body shall provide the director a copy
 of the county's budget for the services to be provided by the county
 veterans' service officer for the fiscal year.

18 "(c) At the end of each calendar quarter, the county governing body 19 shall provide the director a report on the moneys the county expended 20 during the calendar quarter for the services provided by the county 21 veterans' service officer.

"(d) Upon receipt of the county governing body's quarterly report, the director shall distribute to the county governing body a portion of moneys allocated to the county governing body in an amount that is based on the proportion of all moneys budgeted for all services provided by county veterans' service officers that were expended during the calendar quarter.

"(e) At the end of each calendar quarter, the county governing body
 may also provide the director documentation for moneys the county
 expended during a previous calendar quarter in the fiscal year for the

services provided by the county veterans' service officer that the 1 county had not previously reported to the director and for which the  $\mathbf{2}$ county governing body has not received a distribution of moneys from 3 the director. Upon receipt of the documentation, the director shall 4 distribute to the county governing body a portion of moneys allocated  $\mathbf{5}$ to the county governing body in an amount that is based on the pro-6 portion of all moneys budgeted for all services provided by county 7 veterans' service officers that were expended during the calendar 8 quarter within which the county expended the moneys for which the 9 county governing body provided the director documentation. 10

"(3) At the end of each fiscal year, the director shall calculate the 11 remaining moneys not distributed during the fiscal year and distribute 12 the remaining moneys using a formula established under ORS 406.454 13 to each county governing body that expended 90 percent or more of the 14 moneys that the county budgeted for services provided by the county 15veterans' service officer for the fiscal year as specified under sub-16 section (2)(b) of this section. The director shall distribute the remain-17 ing moneys within 90 days from the last date of the fiscal year. 18

"[(2)] (4) Notwithstanding subsection (1) of this section, the director may reduce the amount of moneys distributed to county governing bodies for county veterans' service officers if there is a decrease in the amount of General Fund or State Lottery Fund revenues appropriated to the director for the purposes described in ORS 406.450 for the same period of time.

24 "SECTION 12. Not later than January 2, 2027, the Department of 25 Veterans' Affairs shall prepare and submit a report to the interim 26 committees of the Legislative Assembly related to veterans and the 27 Association of Oregon Counties on the distribution of moneys under 28 the process provided by the amendments to ORS 406.462 by section 11 29 of this 2025 Act.

<sup>3</sup> **"SECTION 13.** ORS 408.425 is amended to read:

"408.425. (1) Each county clerk who receives a request to inspect veteran
discharge papers that are recorded under ORS 408.420 shall produce the recorded discharge papers for inspection if:

7 "(a) The request for inspection is made in writing;

8 "(b) The request sets forth the name, address and telephone number of the9 requester;

"(c) The request sets forth the name and the date of birth or the last four
 digits of the Social Security number of the veteran; and

12 "(d) The request is made by:

"(A) The veteran or [*the spouse, legal guardian*] a person holding a
 power of attorney for the veteran or personal representative of the vet eran; or

16 "[(B) A county veterans' service officer appointed under ORS 408.410;]

17 "[(C) A representative of the Department of Veterans' Affairs; or]

"[(D)] (B) A licensed funeral establishment seeking to ascertain if a
 decedent was a veteran for the purpose of obtaining veteran's burial benefits.
 "(2) This section does not create a cause of action and may not be asserted as the basis of a per se negligence claim.

"(3) Each county clerk may adopt additional policies in order to protect
 recorded discharge papers from malicious or unlawful use and policies re garding copying of recorded discharge papers.

"(4) Each county clerk shall maintain in the records of the county clerk
a copy of each request for inspection of recorded discharge information for
a period of at least 10 years after the date the request is received by the
county clerk.

"(A) Any program for which United States Department of Veterans Affairs education benefits may be used;

6 "(a) May not exceed [\$5,000] **\$10,000** per veteran; and

"(b) May be made only when there are sufficient moneys in the Veteran
Educational Bridge Grant Program Fund established under ORS 408.125 to
make the grants.

"(3) The Department of Veterans' Affairs shall adopt rules for the imple mentation and operation of the program, including eligibility requirements
 for grant applicants.

"(4) As used in this section, 'veteran' has the meaning given that term in
 ORS 408.225 and includes disabled veterans, as defined in ORS 408.225.

"(2) The Judicial Department shall submit a report on the plan in
the manner provided by ORS 192.245, and may include recommendations for legislation, to the interim committees of the Legislative
Assembly related to veterans no later than September 15, 2026.

"(3) As used in this section, 'veterans' court' means a specialized
 court or court program for defendants who are military veterans.
