## PROPOSED AMENDMENTS TO SENATE BILL 539

On page 1 of the printed bill, line 2, after "facilities" insert a period and delete the rest of the line and line 3.

3 Delete lines 5 through 22 and delete pages 2 through 11 and insert:

4 "SECTION 1. Sections 2 and 3 of this 2025 Act are added to and 5 made a part of ORS chapter 442.

6 "SECTION 2. (1) As used in sections 2 and 3 of this 2025 Act:

7 "(a) 'Facility fee' means a fee charged or billed by a hospital-based
8 facility that:

9 "(A) Is intended to cover building, electronic medical records sys-10 tems, billing, administrative and operational expenses.

"(B) Is in addition to and separate from a professional fee for ser vices of a physician.

13 **"(b) 'Health system' means:** 

"(A) A parent corporation of one or more hospitals and any entity
 affiliated with the parent corporation through ownership, governance,
 control or membership; or

"(B) A hospital and any entity affiliated with the hospital through
 ownership, governance, control or membership.

"(c) 'Hospital-based facility' means an off-campus clinic or provider
 office that:

21 "(A) Is owned by a hospital licensed in this state or the hospital's

1 health system;

"(B) Is primarily engaged in providing diagnostic and therapeutic
care, including medical history, physical examinations, assessment of
health status and treatment monitoring;

"(C) Is not a clinic or office that is exclusively designed for and
providing laboratory, X-ray, testing, therapy, pharmacy or educational
services; and

8 "(D) Is not designated as a rural health clinic.

9 "(2) If a hospital licensed in this state or the hospital's health sys-10 tem owns or operates a hospital-based facility for which a facility fee 11 is charged or billed, the hospital or the hospital's health system shall 12 report annually to the Oregon Health Authority, in the form and 13 manner prescribed by the authority, the following information, for the 14 prior calendar year:

"(a) The number of hospital-based facilities owned or operated by
 the hospital or hospital's health system that charge or bill a facility
 fee;

"(b) The number of patient visits at each hospital-based facility for
which a facility fee was charged or billed;

"(c) The revenue amount from facility fees of each hospital-based
facility that is received by the hospital or hospital's health system; and
"(d) The range of allowable facility fees paid by public or private
payers at each hospital-based facility.

24 "<u>SECTION 3.</u> (1) If a hospital-based facility charges a facility fee,
 25 the hospital-based facility shall:

"(a) Provide notice to each patient prior to the delivery of non emergency services;

"(b) At each hospital-based facility location, post a notice promi nently in locations easily accessible to and visible by patients; and
 "(c) Post a notice on the hospital-based facility's website in a lo-

1 cation that is easily accessible by the public.

"(2) A notice that is provided or posted under subsection (1) of this
section must include a statement that:

"(a) The hospital-based facility is licensed as part of a hospital; and
"(b) A patient may be charged or billed a facility fee that may result
in a higher out-of-pocket expense for the patient.

"(3) This section does not apply to laboratory services, imaging
services or other ancillary health services that are not provided by
staff employed by a hospital or hospital-based facility.".
