**PROPOSED AMENDMENTS TO
HOUSE BILL 3902**

1 On page 1 of the printed bill, line 2, delete “and prescribing an effective
2 date” and insert “and declaring an emergency”.

3 Delete lines 11 through 23 and insert:

4 “(a) One member who has a background in academia related to nursing
5 education;

6 “(b) One member who represents the Oregon Health and Science Univer-
7 sity;

8 “(c) One member who is employed by a hospital as a nurse and preceptor;

9 “(d) One member who represents a statewide association that represents
10 nurses;

11 “(e) One member who is a faculty member at a public university listed in
12 ORS 352.002, has experience in nursing education and is a member of the
13 Oregon chapter of a national organization that represents workers in public
14 and private schools, community colleges and higher education;

15 “(f) One member who is a faculty member at an Oregon-based, generally
16 accredited, nonprofit private institution of higher education and who has
17 experience in nursing education;

18 “(g) One member who is a faculty member at an Oregon-based community
19 college, has experience in nursing education and is a member of a statewide
20 organization that represents educators in public schools and community col-
21 leges in this state;

1 “(h) One member who represents the Oregon State Board of Nursing;

2 “(i) One member who is employed in a role that focuses on clinical
3 placements for nursing education;

4 “(j) One member who is a faculty member at a career college that is au-
5 thorized to confer academic degrees and who has experience in nursing edu-
6 cation; and

7 “(k) One member who represents the Higher Education Coordinating
8 Commission.”.

9 On page 2, line 22, delete “nursing”.

10 In line 23, delete the period and insert “for registered nurses, licensed
11 practical nurses and certified nursing assistants.”.

12 Delete lines 27 through 43 and insert:

13 “(3) The board shall appoint to the advisory committee 13 members as
14 follows:

15 “(a) One member who is employed by a hospital as a nurse;

16 “(b) One member who represents the Oregon State Board of Nursing;

17 “(c) One member who is employed by an outpatient clinic as a nurse;

18 “(d) One member who is employed by a long term care facility as a nurse;

19 “(e) One member who is employed as a licensed practical nurse;

20 “(f) One member who is employed as a certified nursing assistant;

21 “(g) One member who represents a statewide association that represents
22 nurses;

23 “(h) One member who represents a statewide association that represents
24 emergency nurses;

25 “(i) One member who represents a statewide association that represents
26 health care workers, public sector workers and property services workers;

27 “(j) One member who represents health care faculty in Oregon;

28 “(k) One member of the administrative staff of a hospital in this state;

29 “(L) One member who represents a long term care facility; and

30 “(m) One member who represents a statewide association that represents

1 hospitals in this state.”.

2 On page 3, delete line 8 and insert “recommendations on compensation for
3 registered nurses, licensed practical nurses and certified nursing
4 assistants.”.

5 Delete lines 23 through 25 and insert:

6 **“SECTION 3. In order to convene the advisory committees described**
7 **in sections 1 and 2 of this 2025 Act, the Oregon State Board of Nursing**
8 **may enter into an agreement with a nonprofit organization in this**
9 **state that facilitates research and collaboration for Oregon’s nursing**
10 **workforce to support informed, well-prepared, diverse and exceptional**
11 **nursing professionals. The board may disburse funds to the organiza-**
12 **tion described in this section for the purpose of carrying out the**
13 **agreement described in this section.**

14 **“SECTION 4. Sections 1 to 3 of this 2025 Act are repealed on June**
15 **2, 2027.**

16 **“SECTION 5. Notwithstanding any other law limiting expenditures,**
17 **the amount of \$150,000 is established for the biennium beginning July**
18 **1, 2025, as the maximum limit for payment of expenses from fees,**
19 **moneys or other revenues, including Miscellaneous Receipts, but ex-**
20 **cluding lottery funds and federal funds, collected or received by the**
21 **Oregon State Board of Nursing, for the purpose of carrying out the**
22 **provisions of sections 1 to 3 of this 2025 Act.**

23 **“SECTION 6. This 2025 Act being necessary for the immediate**
24 **preservation of the public peace, health and safety, an emergency is**
25 **declared to exist, and this 2025 Act takes effect on its passage.”.**
