**PROPOSED AMENDMENTS TO
SENATE BILL 27**

1 In line 2 of the printed bill, after “workforce” insert “; and declaring an
2 emergency”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Oregon Health Authority, for the
6 biennium beginning July 1, 2025, out of the General Fund, the amount
7 of \$20,000,000, for the purpose of paying the nonfederal share of the
8 Oregon Essential Workforce Health Care Program established under
9 ORS 735.520.**

10 **“SECTION 2. In addition to and not in lieu of any other appropri-
11 ation, there is appropriated to the Oregon Health Authority, for the
12 biennium beginning July 1, 2025, out of the General Fund, the amount
13 of \$2,500,000, for the purpose of paying the nonfederal share of the
14 Oregon CareWorks Supplemental Payment Program.**

15 **“SECTION 3. In addition to and not in lieu of any other appropri-
16 ation, there is appropriated to the Oregon Health Authority, for the
17 biennium beginning July 1, 2025, out of the General Fund, the amount
18 of \$2,500,000, for the purpose of providing reimbursements to hospitals
19 participating in a labor-management training trust, as provided in
20 ORS 676.479, as amended by section 2, chapter ____, Oregon Laws 2025
21 (Enrolled Senate Bill 283).**

1 **“SECTION 4. In addition to and not in lieu of any other appropri-**
2 **ation, there is appropriated to the Oregon Health Authority, for the**
3 **biennium beginning July 1, 2025, out of the General Fund, the amount**
4 **of \$9,500,000, for the purpose of providing an incentive payment to**
5 **federally qualified health centers, as provided in ORS 676.479, as**
6 **amended by section 2, chapter ____, Oregon Laws 2025 (Enrolled Senate**
7 **Bill 283).**

8 **“SECTION 5. In addition to and not in lieu of any other appropri-**
9 **ation, there is appropriated to the Oregon Health Authority, for the**
10 **biennium beginning July 1, 2025, out of the General Fund, the amount**
11 **of \$15,000,000, for the purpose of providing reimbursements to support**
12 **clinical education at hospitals under ORS 676.476.**

13 **“SECTION 6. In addition to and not in lieu of any other appropri-**
14 **ation, there is appropriated to the Department of Human Services, for**
15 **the biennium beginning July 1, 2025, out of the General Fund, the**
16 **amount of \$10,000,000, for the purpose of providing reimbursements to**
17 **support clinical education in long term care facilities and residential**
18 **care facilities under ORS 676.476, as amended by section 1, chapter**
19 **____, Oregon Laws 2025 (Enrolled Senate Bill 283).**

20 **“SECTION 7. This 2025 Act being necessary for the immediate**
21 **preservation of the public peace, health and safety, an emergency is**
22 **declared to exist, and this 2025 Act takes effect on its passage.”.**
