**PROPOSED AMENDMENTS TO
HOUSE BILL 3008**

1 Delete lines 4 through 17 of the printed bill and insert:

2 **“SECTION 1. (1) The Higher Education Coordinating Commission**
3 **shall use the moneys appropriated under section 4 of this 2025 Act to**
4 **award grants to Portland State University for the purpose of funding**
5 **recruitment and retention payments to individuals who receive re-**
6 **sources, training and career development opportunities through the**
7 **center that is operated within the university that provides career de-**
8 **velopment, training and certifications to professionals within the child**
9 **care workforce.**

10 **“(2) The commission shall condition grants awarded under this**
11 **section on the grant recipient certifying, to the satisfaction of the**
12 **commission, that the center affirms that all programs, services and**
13 **initiatives that are administered through the center will be accessible**
14 **to all individuals based on merit and without discrimination or pref-**
15 **erential treatment on the basis of race or ethnicity.**

16 **“SECTION 2. (1) The Department of Administrative Services shall**
17 **use the moneys appropriated under section 5 of this 2025 Act to award**
18 **grants to the entity identified in section 5 of this 2025 Act to provide**
19 **health care benefits to child care providers.**

20 **“(2) The department shall establish by rule the grant application**
21 **process and procedures for verifying that the grant moneys have been**

1 used for the purposes for which they were awarded.

2 **“SECTION 3.** (1) The Department of Administrative Services shall
3 use the moneys appropriated under section 6 of this 2025 Act to award
4 grants to the eligible entities that administer child care workforce
5 training programs.

6 **“(2)** The department shall establish by rule the grant eligibility
7 criteria, application process and procedures for verifying that the
8 grant moneys have been used for the purposes for which they were
9 awarded.

10 **“SECTION 4.** In addition to and not in lieu of any other appropri-
11 ation, there is appropriated to the Higher Education Coordinating
12 Commission, for the biennium beginning July 1, 2025, out of the Gen-
13 eral Fund, the amount of \$_____, for distribution to Portland State
14 University to fund recruitment and retention payments to child care
15 providers working in Oregon through the Oregon Center for Career
16 Development in Childhood Care and Education.

17 **“SECTION 5.** In addition to and not in lieu of any other appropri-
18 ation, there is appropriated to the Oregon Department of Administra-
19 tive Services, for the biennium beginning July 1, 2025, out of the
20 General Fund, the amount of \$_____, for distribution to United We
21 Heal Training Trust to provide health care benefits to child care pro-
22 viders.

23 **“SECTION 6.** In addition to and not in lieu of any other appropri-
24 ation, there is appropriated to the Oregon Department of Administra-
25 tive Services, for the biennium beginning July 1, 2025, out of the
26 General Fund, the amount of \$_____, for distribution to child care
27 workforce training programs.”.
