6 "<u>SECTION 3.</u> Before June 1, 2027, and notwithstanding section 2 7 (3)(b) of this 2025 Act, for each dwelling unit that is subject to section 8 2 (2) of this 2025 Act on the operative date specified in section 4 of this 9 2025 Act, the landlord shall sample and test for all contaminants as 10 described in section 2 (5) of this 2025 Act.

"SECTION 4. (1) Section 2 of this 2025 Act becomes operative on
January 1, 2027.

"(2) The Oregon Health Authority may take any action before the operative date specified in subsection (1) of this section that is necessary for the authority to exercise, on and after the operative date specified in subsection (1) of this section, all of the duties, functions and powers conferred on the authority by section 2 of this 2025 Act.".
