**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2684**

1 On page 1 of the printed A-engrossed bill, delete lines 5 through 27.

2 On page 2, delete lines 1 through 20 and insert:

3 **“SECTION 1.** ORS 634.705 is amended to read:

4 “634.705. (1)(a) The governing body responsible for a school shall adopt
5 an integrated pest management plan for use on the campuses of the school.

6 The governing body shall also adopt provisions for:

7 “[a)] (A) Designating an integrated pest management plan coordinator;

8 “[b)] (B) Identifying plan coordinator responsibilities;

9 “[c)] (C) Giving notices under ORS 634.740;

10 “[d)] (D) Retaining pesticide application records under ORS 634.750;

11 “[e)] (E) Providing a process for responding to inquiries and complaints
12 about noncompliance with the integrated pest management plan; and

13 “[f)] (F) Conducting outreach to the school community about the school’s
14 integrated pest management plan.

15 **“(b) Not less than once every five years, the governing body shall**
16 **review the integrated pest management plan, make any necessary up-**
17 **dates and readopt the integrated pest management plan. A final in-**
18 **tegrated pest management plan must include the day, month and year**
19 **that the governing body adopted or readopted the plan.**

20 **“(c) A governing body shall make the integrated pest management**
21 **plan available to the public through the governing body’s website. A**

1 **governing body may satisfy this paragraph by including the integrated**
2 **pest management plan with the Healthy and Safe Schools Plan,**
3 **adopted under ORS 332.331, posted on the governing body’s website.**

4 “(2) If a governing body has control over only part of a building, a
5 structure or property where a campus is located, the governing body may
6 limit an integrated pest management plan to those parts of the building,
7 structure or property over which the governing body exerts substantial con-
8 trol.

9 “(3) A governing body is not required to adopt an integrated pest man-
10 agement plan for off-campus buildings, structures or property, notwithstand-
11 ing any incidental use for instruction.

12 “(4) Unless a governing body expressly provides otherwise, the application
13 of a germicide, disinfectant, sanitizer, deodorizer, antimicrobial agent or
14 insecticidal soap at a campus is not subject to the requirements for a pesti-
15 cide application under an integrated pest management plan. However, this
16 subsection does not permit the application at a campus of a germicide,
17 disinfectant, sanitizer, deodorizer, antimicrobial agent or insecticidal soap
18 that is a pesticide in a manner that is inconsistent with the goal of the in-
19 tegrated pest management plan.

20 “(5)(a) A governing body shall adopt a list of low-impact pesticides for
21 use with the integrated pest management plan.

22 **“(b) A governing body shall make the list of low-impact pesticides**
23 **available to the public through the governing body’s website. A gov-**
24 **erning body may satisfy this paragraph by including the list of low-**
25 **impact pesticides with the Healthy and Safe Schools Plan, adopted**
26 **under ORS 332.331, posted on the governing body’s website.**

27 **“(c) The [governing body] list of low-impact pesticides** may include any
28 product [on the list] except products that:

29 **“[(a)] (A) Contain a pesticide product or active ingredient that has the**
30 **signal words ‘warning’ or ‘danger’ on the label;**

1 “[*(b)*] **(B)** Contain a pesticide product classified as a human carcinogen
2 or probable human carcinogen under the United States Environmental Pro-
3 tection Agency 1986 Guidelines for Carcinogen Risk Assessment; or

4 “[*(c)*] **(C)** Contain a pesticide product classified as carcinogenic to humans
5 or likely to be carcinogenic to humans under the United States Environ-
6 mental Protection Agency 2003 Draft Final Guidelines for Carcinogen Risk
7 Assessment.”.
