2 of this 2025 Act and the repeal of ORS 688.040 and 688.090 by section  
3 22 of this 2025 Act become operative on January 1, 2026.

4 “(2) The Oregon Board of Physical Therapy may take any action  
5 before the operative date specified in subsection (1) of this section that  
6 is necessary to enable the board to exercise, on and after the operative  
7 date specified in subsection (1) of this section, all of the duties, func-  
8 tions and powers conferred on the board by sections 2 to 7 of this 2025  
9 Act, the amendments to ORS 688.010, 688.015, 688.020, 688.030, 688.050,  
10 688.055, 688.080, 688.100, 688.110, 688.135, 688.140, 688.160, 688.435 and  
11 811.604 by sections 8 to 21 of this 2025 Act and the repeal of ORS 688.040  
12 and 688.090 by section 22 of this 2025 Act.

13 “SECTION 25. This 2025 Act takes effect on the 91st day after the  
14 date on which the 2025 regular session of the Eighty-third Legislative  
15 Assembly adjourns sine die.”.
