"(b) In determining fair market value under this subsection, the fair
market value of the entire interest in the property included in the estate
shall be used without reduction for liens or other debts.

"(3) As used in this section, 'manufactured home' means a structure constructed for movement on the public highways that has sleeping, cooking and plumbing facilities, that is intended for human occupancy, that is being used for residential purposes and that was constructed in accordance with federal manufactured housing construction and safety standards and regulations in effect at the time of construction.

"SECTION 1a. If Senate Bill 168 becomes law, section 1 of this 2025
Act (amending ORS 114.510) is repealed and ORS 114.510, as amended
by section 2, chapter 34, Oregon Laws 2025 (Enrolled Senate Bill 168),
is amended to read:

"114.510. (1) A person who meets the requirements of ORS 114.515 may file
a simple estate affidavit only with regard to an estate in which:

"(a)(A) Not more than \$75,000 of the fair market value of the estate is
attributable to personal property other than manufactured homes; and
