- "(2) The moneys in the Employment Department Special Fraud Control Fund are continuously appropriated to the Employment Department and may not be appropriated, transferred or otherwise made available to any other

- 2 "(3) All amounts in the Employment Department Special Fraud Control
- 3 Fund shall be used for the following purposes, as included in the biennial
