"SECTION 4. ORS 618.136, as amended by section 2, chapter 385, Oregon
 Laws 2019, is amended to read:

"618.136. (1) The license fee for each type or class of commercial weighing 13 or measuring instrument or device shall be established by the State Depart-14 ment of Agriculture in an amount not to exceed the maximum limits under 15ORS 618.141. Such fees shall be established in the amounts necessary for the 16 department to carry out and enforce the provisions of ORS 618.010 to 618.246 17 relating to the supervision of commercial weighing and measuring instru-18 ments or devices, and to maintain an emergency fund with an unencumbered 19 balance in an amount not to exceed the cost of administering ORS 618.010 20 to 618.246 during a representative four-month period in order to ensure the 21

orderly supervision of commercial weighing and measuring instruments or
 devices within this state.

"(2) License fees become past due July 1 each year for renewals, and on
the date of first commercial use for original installations.

"(3) Except as provided in this subsection, the department may not $\mathbf{5}$ establish a license fee under this section that is more than three per-6 cent higher than the license fee charged during the preceding year for 7 a commercial weighing or measuring instrument or device of the same 8 type and class. Notwithstanding the three percent limit but subject to 9 the maximum limits under ORS 618.141, when establishing a license fee 10 under this section the department may round the fee amount to the 11 next higher whole dollar amount. The department may not change the 12 license fee for the same type and class of commercial weighing or 13 measuring instrument or device more than once each year. 14

¹⁵ "[(3)] (4) All moneys received by the department pursuant to ORS 618.010 ¹⁶ to 618.246 shall be paid into the Department of Agriculture Service Fund. ¹⁷ Such moneys are continuously appropriated to the department for the pur-¹⁸ pose of administering those provisions of ORS 618.010 to 618.246 relating to ¹⁹ testing, inspection, licensing and regulation of commercial weighing and ²⁰ measuring instruments or devices.".
