**PROPOSED AMENDMENTS TO
HOUSE BILL 5026**

On page 1 of the printed bill, delete lines 5 through 26 and delete page 2 and insert:

“SECTION 1. There is appropriated to the State Parks and Recreation Department, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$8,476,750 for debt service.

“SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2025, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the State Parks and Recreation Department, for the following purposes:

11 **moneys allocated from the Administrative Services Economic Devel-**
12 **opment Fund to the State Parks and Recreation Department for the**
13 **payment of debt service.**

15 **the following amounts are established for the biennium beginning July**
16 **1, 2025, as the maximum limits for payment of expenses from federal**
17 **funds collected or received by the State Parks and Recreation Depart-**
