Notwithstanding any other law limiting expenditures, the amount of \$2,558,120 is established for the biennium beginning July 1, 2025, as the maximum limit for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the State Forestry Department for debt service relating to the purchase of land in the Gilchrist State Forest.

"SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2025, as the maximum limits for payment of expenses from federal funds other than those described in section 2 of this 2025 Act, collected or received by the State Forestry Department, for the following purposes:

- "SECTION 5. In addition to and not in lieu of any other appropriation, there is appropriated to the State Forestry Department, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$2,000,000, to be deposited into the Small Forestland Investment in Stream Habitat Program Fund established under ORS 526.404, to provide grants to eligible small forestland owners pursuant to ORS 526.402.
