**PROPOSED AMENDMENTS TO
HOUSE BILL 5005**

1 Delete lines 5 through 22 of the printed bill and insert:

2 **“SECTION 1. There is appropriated to the Oregon Criminal Justice**
3 **Commission, for the biennium beginning July 1, 2025, out of the Gen-**
4 **eral Fund, the amount of \$19,514,353.**

5 **“SECTION 2. Notwithstanding any other law limiting expenditures,**
6 **the amount of \$628,510 is established for the biennium beginning July**
7 **1, 2025, as the maximum limit for payment of expenses from lottery**
8 **moneys allocated from the Veterans’ Services Fund established under**
9 **ORS 406.140 to the Oregon Criminal Justice Commission, for veterans’**
10 **specialty courts.**

11 **“SECTION 3. Notwithstanding any other law limiting expenditures,**
12 **the amount of \$151,247,749 is established for the biennium beginning**
13 **July 1, 2025, as the maximum limit for payment of expenses from fees,**
14 **moneys or other revenues, including Miscellaneous Receipts, but ex-**
15 **cluding lottery funds and federal funds, collected or received by the**
16 **Oregon Criminal Justice Commission.**

17 **“SECTION 4. Notwithstanding any other law limiting expenditures,**
18 **the amount of \$15,098,131 is established for the biennium beginning**
19 **July 1, 2025, as the maximum limit for payment of expenses from fed-**
20 **eral funds collected or received by the Oregon Criminal Justice Com-**
21 **mission.**

1 **“SECTION 5. In addition to and not in lieu of any other appropri-**
2 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
3 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
4 **the amount of \$54,861,333, for deposit into the Oregon Public Safety**
5 **Fund established by section 4, chapter __, Oregon Laws 2025 (Enrolled**
6 **House Bill 3069).**

7 **“SECTION 6. In addition to and not in lieu of any other appropri-**
8 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
9 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
10 **the amount of \$15,560,850, for deposit into the Oregon Treatment Court**
11 **Grant Program Account established by section 22, chapter __, Oregon**
12 **Laws 2025 (Enrolled House Bill 3069).**

13 **“SECTION 7. In addition to and not in lieu of any other appropri-**
14 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
15 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
16 **the amount of \$4,715,308, for deposit into the Organized Retail Theft**
17 **Grant Program Account established by section 25, chapter __, Oregon**
18 **Laws 2025 (Enrolled House Bill 3069).**

19 **“SECTION 8. In addition to and not in lieu of any other appropri-**
20 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
21 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
22 **the amount of \$40,000,000, for deposit into the Oregon Behavioral**
23 **Health Deflection Program Account established by section 78, chapter**
24 **70, Oregon Laws 2024.**

25 **“SECTION 9. In addition to and not in lieu of any other appropri-**
26 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
27 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
28 **the amount of \$10,000,000, for deposit into the Improving People’s Ac-**
29 **cess to Community-based Treatment, Supports and Services Account**
30 **established by ORS 430.233.**

1 **“SECTION 10. In addition to and not in lieu of any other appropri-**
2 **ation, there is appropriated to the Oregon Criminal Justice Commis-**
3 **sion, for the biennium beginning July 1, 2025, out of the General Fund,**
4 **the amount of \$6,000,000, for deposit into the Oregon Jail-Based**
5 **Medications for Opioid Use Disorder Fund established by section 87,**
6 **chapter 70, Oregon Laws 2024.**

7 **“SECTION 11. This 2025 Act being necessary for the immediate**
8 **preservation of the public peace, health and safety, an emergency is**
9 **declared to exist, and this 2025 Act takes effect July 1, 2025.”.**
