**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2015**

1 On page 3 of the printed A-engrossed bill, delete lines 25 through 28 and
2 insert:

3 **SECTION 3. Notwithstanding any other provision of law, the**
4 **General Fund appropriation made to the Oregon Health Authority by**
5 **section 1 (1), chapter __, Oregon Laws 2025 (Enrolled House Bill 5025),**
6 **for the biennium beginning July 1, 2025, is increased by \$706,070 to**
7 **carry out the provisions of sections 1 and 2 of this 2025 Act.**

8 **SECTION 4. Notwithstanding any other provision of law, the**
9 **General Fund appropriation made to the Oregon Health Authority by**
10 **section 1 (2), chapter __, Oregon Laws 2025 (Enrolled House Bill 5025),**
11 **for the biennium beginning July 1, 2025, is increased by \$581,259 to**
12 **carry out the provisions of sections 1 and 2 of this 2025 Act.**

13 **SECTION 5. Notwithstanding any other law limiting expenditures,**
14 **the limitation on expenditures established by section 5 (1), chapter __,**
15 **Oregon Laws 2025 (Enrolled House Bill 5025), for the biennium begin-**
16 **ning July 1, 2025, as the maximum limit for payment of expenses from**
17 **federal funds, excluding federal funds described in section 2, chapter**
18 **__, Oregon Laws 2025 (Enrolled House Bill 5025), collected or received**
19 **by the Oregon Health Authority, is increased by \$706,070 to carry out**
20 **the provisions of sections 1 and 2 of this 2025 Act.**

21 **SECTION 6. Notwithstanding any other law limiting expenditures,**

1 the limitation on expenditures established by section 5 (2), chapter __,
2 Oregon Laws 2025 (Enrolled House Bill 5025), for the biennium begin-
3 ning July 1, 2025, as the maximum limit for payment of expenses from
4 federal funds, excluding federal funds described in section 2, chapter
5 __, Oregon Laws 2025 (Enrolled House Bill 5025), collected or received
6 by the Oregon Health Authority, is increased by \$271,818 to carry out
7 the provisions of sections 1 and 2 of this 2025 Act.

8 **SECTION 7.** Sections 1 and 2 of this 2025 Act are repealed on Jan-
9 uary 2, 2027.

10 **SECTION 8.** This 2025 Act being necessary for the immediate
11 preservation of the public peace, health and safety, an emergency is
12 declared to exist, and this 2025 Act takes effect on its passage.”.
