- "(a) Judicial education requirements to strengthen the skills, resilience and performance of the members of the Judicial Conference of the State of Oregon;
- 25 "(b) An ombudsman's office within the office of the State Court
 26 Administrator to receive and respond to comments and concerns re27 garding court experiences;
- 28 "(c) Rules and standards governing the resolution of concerns re-29 garding judicial performance;

- "(2) Nothing in this section prevents the Chief Justice or any other individual from referring a matter to the Commission on Judicial Fitness and Disability.

Notwithstanding any other provision of law, the General Fund appropriation made to the Judicial Department by section 1 (1), chapter ____, Oregon Laws 2025 (Enrolled House Bill 5012), for the biennium beginning July 1, 2025, for judicial compensation, is increased by \$11,328,430 for implementation of the provisions of sections 1 to 4 of this 2025 Act.
 - "SECTION 7. Notwithstanding any other provision of law, the General Fund appropriation made to the Judicial Department by section 1 (2), chapter ___, Oregon Laws 2025 (Enrolled House Bill 5012), for the biennium beginning July 1, 2025, for operations, is increased by \$1,909,655 for implementation of the provisions of section 5 of this 2025 Act.
 - "SECTION 8. This 2025 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect on its passage."
