**PROPOSED AMENDMENTS TO RESOLVE CONFLICTS TO  
A-ENGROSSED SENATE BILL 230**

1 On page 2 of the printed A-engrossed bill, after line 10, insert:

2 **“SECTION 1a. If House Bill 2211 becomes law, section 1 of this 2025**  
3 **Act (amending ORS 413.650) is repealed and ORS 413.650, as amended**  
4 **by section 5, chapter 252, Oregon Laws 2025 (Enrolled House Bill 2211),**  
5 **is amended to read:**

6 “413.650. (1) As used in this section:

7 “(a) ‘Dental subcontractor’ and ‘medical assistance’ have the meaning  
8 given those terms in ORS 414.025.

9 “(b) ‘Veteran’ means an individual who is a veteran, as defined in ORS  
10 408.225, except the individual may be discharged or released under honorable  
11 or other than honorable conditions.

12 “(2) The Veterans Dental Program is established in the Oregon Health  
13 Authority and shall be administered in collaboration with the Department  
14 of Consumer and Business Services. The purpose of the program is to provide  
15 oral health care to eligible veterans who are residing in Oregon.

16 “(3) The authority shall contract with dental subcontractors throughout  
17 this state and with individual oral health care providers in areas of this  
18 state that are not served by dental subcontractors to provide oral health care  
19 to veterans enrolled in the Veterans Dental Program.

20 “(4) Enrollees in the Veterans Dental Program shall receive the types and  
21 extent of oral health care services that the authority determines will be

1 provided to medical assistance recipients in accordance with ORS 414.065,  
2 without any corresponding copayments, deductibles or cost sharing required.

3 “(5) An individual is eligible for the Veterans Dental Program if the in-  
4 dividual:

5 “(a) Is a resident of Oregon;

6 “(b) Is ineligible for medical assistance;

7 “(c) Has income that is at or below 400 percent of the federal poverty  
8 guidelines; and

9 “(d) Is a veteran.

10 “(6) The authority shall:

11 “(a) Prescribe by rule a simple application process for the Veterans  
12 Dental Program.

13 “(b) Provide assistance, in person or by telephone, to applicants for and  
14 enrollees in the program.

15 “(c) Require and accept as verification of eligibility:

16 “(A) Documentation demonstrating that an applicant’s income is at or  
17 below 400 percent of the federal poverty guidelines.

18 “(B) An applicant’s federal DD Form 214 or 215.

19 **“(d) Require dental subcontractors and individual oral health care**  
20 **providers that contract with the authority to provide oral health care**  
21 **to veterans under this section to complete an intake screening with**  
22 **an enrollee within 60 days after the enrollee initiates contact with the**  
23 **subcontractor or provider.”.**
