**PROPOSED AMENDMENTS TO  
HOUSE BILL 5006**

1 In line 2 of the printed bill, after the semicolon insert “creating new  
2 provisions; amending section 275, chapter 669, Oregon Laws 2021, and section  
3 248, chapter 605, Oregon Laws 2023;”.

4 Delete lines 4 through 24 and insert:

5 **“SECTION 1. In addition to and not in lieu of any other appropri-  
6 ation, there is appropriated to the Emergency Board, for the biennium  
7 beginning July 1, 2025, out of the General Fund, the amount of  
8 \$100,000,000, for the purposes for which the Emergency Board lawfully  
9 may allocate funds.**

10 **“SECTION 2. (1) In addition to and not in lieu of any other appro-  
11 priation, there is appropriated to the Emergency Board, for the  
12 biennium beginning July 1, 2025, out of the General Fund, the amount  
13 of \$300,000,000, to be allocated to state agencies for state employee  
14 compensation changes.**

15 **“(2) If any of the moneys appropriated by subsection (1) of this  
16 section are not allocated by the Emergency Board prior to December  
17 1, 2026, the moneys remaining on that date become available for any  
18 purpose for which the Emergency Board lawfully may allocate funds.**

19 **“SECTION 3. (1) In addition to and not in lieu of any other appro-  
20 priation, there is appropriated to the Emergency Board, for the  
21 biennium beginning July 1, 2025, out of the General Fund, the amount**

1 of \$75,000,000, to be allocated to state agencies for compensation  
2 changes driven by collective bargaining for workers who are not state  
3 employees.

4 “(2) If any of the moneys appropriated by subsection (1) of this  
5 section are not allocated by the Emergency Board prior to December  
6 1, 2026, the moneys remaining on that date become available for any  
7 purpose for which the Emergency Board lawfully may allocate funds.

8 “SECTION 4. (1) In addition to and not in lieu of any other appro-  
9 priation, there is appropriated to the Emergency Board, for the  
10 biennium beginning July 1, 2025, out of the General Fund, the amount  
11 of \$100,000,000, to be allocated to the Oregon Health Authority and the  
12 Department of Human Services for caseload costs the agencies are  
13 unable to mitigate during the interim legislative periods.

14 “(2) If any of the moneys appropriated by subsection (1) of this  
15 section are not allocated by the Emergency Board prior to December  
16 1, 2026, the moneys remaining on that date become available for any  
17 purpose for which the Emergency Board lawfully may allocate funds.

18 “SECTION 5. (1) In addition to and not in lieu of any other appro-  
19 priation, there is appropriated to the Emergency Board, for the  
20 biennium beginning July 1, 2025, out of the General Fund, the amount  
21 of \$150,000,000, to be allocated for the state’s natural disaster pre-  
22 vention, preparedness, response and recovery.

23 “(2) If any of the moneys appropriated by subsection (1) of this  
24 section are not allocated by the Emergency Board prior to December  
25 1, 2026, the moneys remaining on that date become available for any  
26 purpose for which the Emergency Board lawfully may allocate funds.

27 “SECTION 6. (1) In addition to and not in lieu of any other appro-  
28 priation, there is appropriated to the Emergency Board, for the  
29 biennium beginning July 1, 2025, out of the General Fund, the amount  
30 of \$24,000,000, to be allocated to the State Forestry Department for fire

1 **protection expenses.**

2 **“(2) If any of the moneys appropriated by subsection (1) of this**  
3 **section are not allocated by the Emergency Board prior to December**  
4 **1, 2026, the moneys remaining on that date become available for any**  
5 **purpose for which the Emergency Board lawfully may allocate funds.**

6 **“SECTION 7. (1) In addition to and not in lieu of any other appro-**  
7 **priation, there is appropriated to the Emergency Board, for the**  
8 **biennium beginning July 1, 2025, out of the General Fund, the amount**  
9 **of \$35,000,000, to be allocated to the Department of Veterans’ Affairs**  
10 **for the state’s matching funds portion for construction of a veterans’**  
11 **home in Roseburg, Oregon, pursuant to ORS 408.385.**

12 **“(2) If any of the moneys appropriated by subsection (1) of this**  
13 **section are not allocated by the Emergency Board prior to December**  
14 **1, 2026, the moneys remaining on that date become available for any**  
15 **purpose for which the Emergency Board lawfully may allocate funds.**

16 **“SECTION 8. Notwithstanding any other provision of law, the**  
17 **General Fund appropriation made to the Emergency Board by section**  
18 **500 (1), chapter 114, Oregon Laws 2024, for the biennium ending June**  
19 **30, 2025, for the state’s matching funds portion for construction of a**  
20 **veterans’ home in Roseburg, Oregon, pursuant to ORS 408.385, is de-**  
21 **creased by \$35,000,000.**

22 **“NOTE: Section 9 was deleted. Subsequent sections were not renumbered.**

23 **“SECTION 10. In addition to and not in lieu of any other appropri-**  
24 **ation, there is appropriated to the Higher Education Coordinating**  
25 **Commission, for the biennium beginning July 1, 2025, out of the Gen-**  
26 **eral Fund, the amount of \$200,000, for distribution to the Oregon State**  
27 **University Foundation, for the Rural Mental Health Fund, for the ex-**  
28 **penses of the Oregon State University Extension Service to operate the**  
29 **AgriStress Helpline in Oregon.**

30 **“SECTION 11. In addition to and not in lieu of any other appropri-**

1 ation, there is appropriated to the Department of the State Fire Mar-  
2 shal, for the biennium beginning July 1, 2025, out of the General Fund,  
3 the amount of \$13,000,000, for deposit in the Community Risk Re-  
4 duction Fund established under ORS 476.396.

5 **“SECTION 12.** Notwithstanding any other law limiting expenditures,  
6 the limitation on expenditures established by section 2 (1), chapter \_\_,  
7 Oregon Laws 2025 (Enrolled Senate Bill 5538), for the biennium begin-  
8 ning July 1, 2025, as the maximum limit for payment of expenses from  
9 fees, moneys or other revenues, including Miscellaneous Receipts, but  
10 excluding lottery funds and federal funds, collected or received by the  
11 Department of the State Fire Marshal, for the office of the State Fire  
12 Marshal, business services, emergency response, fire and life safety  
13 services and fire and life safety education, is increased by \$13,000,000,  
14 for the Community Risk Reduction Fund established under ORS  
15 476.396.

16 **“SECTION 13.** Notwithstanding any other provision of law, the  
17 General Fund appropriation made to the State Department of Agri-  
18 culture by section 1 (4), chapter \_\_, Oregon Laws 2025 (Enrolled Sen-  
19 ate Bill 5502), for the biennium beginning July 1, 2025, for market  
20 access, is increased by \$1,000,000, for the wolf depredation compen-  
21 sation and financial assistance grant program.

22 **“SECTION 14.** Notwithstanding any other provision of law, the  
23 General Fund appropriation made to the State Department of Fish and  
24 Wildlife by section 1 (1), chapter \_\_, Oregon Laws 2025 (Enrolled  
25 House Bill 5009), for the biennium beginning July 1, 2025, for the Fish  
26 Division, is increased by \$1,400,000, for operations and research at the  
27 Rock Creek Hatchery.

28 **“SECTION 15.** In addition to and not in lieu of any other appropri-  
29 ation, there is appropriated to the Department of State Lands, for the  
30 biennium beginning July 1, 2025, out of the General Fund, the amount

1 of \$442,576, for the Common School Fund program, to assist with  
2 wetland mitigation and housing specific permits and support for local  
3 government land use permitting.

4 **“SECTION 16.** In addition to and not in lieu of any other appropri-  
5 ation, there is appropriated to the Oregon Department of Administra-  
6 tive Services, for the biennium beginning July 1, 2025, out of the  
7 General Fund, the amount of \$10,500,000, for deposit in the Universal  
8 Representation Fund established under ORS 9.865.

9 **“SECTION 17.** Notwithstanding any other law limiting expenditures,  
10 the limitation on expenditures established by section 2 (15), chapter  
11 \_\_\_, Oregon Laws 2025 (Enrolled House Bill 5002), for the biennium  
12 beginning July 1, 2025, as the maximum limit for payment of expenses  
13 from fees, moneys or other revenues, including Miscellaneous Receipts  
14 and federal funds received from charges, but excluding lottery funds  
15 and federal funds not described in section 2, chapter \_\_\_, Oregon Laws  
16 2025 (Enrolled House Bill 5002), collected or received by the Oregon  
17 Department of Administrative Services, for special governmental pay-  
18 ments, is increased by \$10,500,000, for disbursement from the Universal  
19 Representation Fund established under ORS 9.865 to Oregon Worker  
20 Relief, as the fiscal agent described in ORS 9.860.

21 **“SECTION 18.** In addition to and not in lieu of any other appropri-  
22 ation, there is appropriated to the Oregon Department of Administra-  
23 tive Services, for the biennium beginning July 1, 2025, out of the  
24 General Fund, the amount of \$1,468,500, for distribution to the Oregon  
25 Historical Society to be used for operational costs.

26 **“SECTION 19.** In addition to and not in lieu of any other appropri-  
27 ation, there is appropriated to the Oregon Department of Administra-  
28 tive Services, for the biennium beginning July 1, 2025, out of the  
29 General Fund, the amount of \$229,000, for distribution to Oregon Pub-  
30 lic Broadcasting.

1       **“SECTION 20.** In addition to and not in lieu of any other appropri-  
2 ation, there is appropriated to the Oregon Department of Administra-  
3 tive Services, for the biennium beginning July 1, 2025, out of the  
4 General Fund, the amount of \$750,000, for distribution to Pueblo Unido  
5 PDX for facilitating the creation of additional language evaluations for  
6 interpreters of indigenous languages spoken in present-day Mexico and  
7 Central and South America.

8       **“SECTION 21.** In addition to and not in lieu of any other appropri-  
9 ation, there is appropriated to the Oregon Department of Administra-  
10 tive Services, for the biennium beginning July 1, 2025, out of the  
11 General Fund, the amount of \$150,000, for distribution to the Central  
12 Oregon Intergovernmental Council for the coordination and adminis-  
13 trative support of soil and water conservation districts and imple-  
14 menting ORS 568.970.

15       **“SECTION 22.** In addition to and not in lieu of any other appropri-  
16 ation, there is appropriated to the Oregon Department of Administra-  
17 tive Services, for the biennium beginning July 1, 2025, out of the  
18 General Fund, the amount of \$500,000, for distribution to the Central  
19 Oregon Intergovernmental Council for distribution to soil and water  
20 conservation districts for monitoring, or contracting for monitoring,  
21 and implementing ORS 568.970 and 568.972.

22       **“SECTION 23.** In addition to and not in lieu of any other appropri-  
23 ation, there is appropriated to the Oregon Department of Administra-  
24 tive Services, for the biennium beginning July 1, 2025, out of the  
25 General Fund, the amount of \$2,000,000, for distribution to Oregon  
26 Worker Relief to provide farmworker disaster relief.

27       **“SECTION 24.** In addition to and not in lieu of any other appropri-  
28 ation, there is appropriated to the Oregon Department of Administra-  
29 tive Services, for the biennium beginning July 1, 2025, out of the  
30 General Fund, the following amounts, which may be expended to pro-

1 vide the following grants pursuant to ORS 568.970, provided that the  
2 grants are issued within 60 days after the effective date of this 2025  
3 Act:

4 “(1) \$1,235,000 for providing a grant to a soil and water conservation  
5 district located in Crook County.

6 “(2) \$715,000 for providing a grant to a soil and water conservation  
7 district located in Jefferson County.

8 “(3) \$585,000 for providing a grant to a soil and water conservation  
9 district located in Klamath County.

10 “(4) \$585,000 for providing a grant to a soil and water conservation  
11 district located in Deschutes County.

12 “(5) \$580,000 for providing a grant to a soil and water conservation  
13 district located in Harney County.

14 “(6) \$455,000 for providing a grant to a soil and water conservation  
15 district located in Lake County.

16 “(7) \$455,000 for providing a grant to a soil and water conservation  
17 district located in Wheeler County.

18 “SECTION 25. Notwithstanding any other provision of law, the  
19 General Fund appropriation made to the Public Defense Services  
20 Commission by section 1 (1), chapter 481, Oregon Laws 2023, for the  
21 biennium ending June 30, 2025, for the Executive Division, is decreased  
22 by \$350,000, for a budget realignment.

23 “SECTION 26. Notwithstanding any other provision of law, the  
24 General Fund appropriation made to the Public Defense Services  
25 Commission by section 1 (4), chapter 481, Oregon Laws 2023, for the  
26 biennium ending June 30, 2025, for the Adult Trial Division, is de-  
27 creased by \$2,525,000, for a budget realignment.

28 “SECTION 27. Notwithstanding any other provision of law, the  
29 General Fund appropriation made to the Public Defense Services  
30 Commission by section 1 (5), chapter 481, Oregon Laws 2023, for the

1 biennium ending June 30, 2025, for the Juvenile Trial Division, is de-  
2 creased by \$200,000, for a budget realignment.

3 **SECTION 28.** Notwithstanding any other provision of law, the  
4 General Fund appropriation made to the Public Defense Services  
5 Commission by section 1 (6), chapter 481, Oregon Laws 2023, for the  
6 biennium ending June 30, 2025, for Preauthorized Expenses, is in-  
7 creased by \$1,000,000, for a budget realignment.

8 **SECTION 29.** Notwithstanding any other provision of law, the  
9 General Fund appropriation made to the Public Defense Services  
10 Commission by section 1 (7), chapter 481, Oregon Laws 2023, for the  
11 biennium ending June 30, 2025, for Court Mandated Expenses, is in-  
12 creased by \$4,200,000, for a budget realignment.

13 **SECTION 30.** Notwithstanding any other provision of law, the  
14 General Fund appropriation made to the Public Defense Services  
15 Commission by section 1 (8), chapter 481, Oregon Laws 2023, for the  
16 biennium ending June 30, 2025, for the Parent Child Representation  
17 Program, is decreased by \$600,000, for a budget realignment.

18 **SECTION 31.** Notwithstanding any other provision of law, the  
19 General Fund appropriation made to the Public Defense Services  
20 Commission by section 1 (9), chapter 481, Oregon Laws 2023, for the  
21 biennium ending June 30, 2025, for the Administrative Services Divi-  
22 sion, is decreased by \$1,525,000, for a budget realignment.

23 **SECTION 32.** In addition to and not in lieu of any other appropri-  
24 ation, there is appropriated to the Judicial Department, for the  
25 biennium beginning July 1, 2025, out of the General Fund, the amount  
26 of \$4,500,000, for the purposes of implementing ORS 9.860 (4).

27 **SECTION 33.** Notwithstanding any other law limiting expenditures,  
28 the limitation on expenditures established by section 1 (1), chapter 473,  
29 Oregon Laws 2023, for the biennium ending June 30, 2025, as the max-  
30 imum limit for payment of expenses from fees, moneys or other reve-

1 nues, including Miscellaneous Receipts, but excluding lottery funds  
2 and federal funds, collected or received by the State Marine Board, for  
3 administration and education, is increased by \$167,825, for boating  
4 safety education, enforcement and contracted services.

5 **“SECTION 34.** Notwithstanding any other law limiting expenditures,  
6 the limitation on expenditures established by section 1 (2), chapter 473,  
7 Oregon Laws 2023, for the biennium ending June 30, 2025, as the max-  
8 imum limit for payment of expenses from fees, moneys or other reve-  
9 nues, including Miscellaneous Receipts, but excluding lottery funds  
10 and federal funds, collected or received by the State Marine Board, for  
11 marine law enforcement, is increased by \$2,067,759, for boating safety  
12 education, enforcement and contracted services.

13 **“SECTION 35.** Notwithstanding any other provision of law, the  
14 General Fund appropriation made to the Oregon Military Department  
15 by section 1 (4), chapter \_\_, Oregon Laws 2025 (Enrolled Senate Bill  
16 5533), for the biennium beginning July 1, 2025, for capital debt service  
17 and related costs, is increased by \$1,872,675, for debt service.

18 **“SECTION 36.** Notwithstanding any other law limiting expenditures,  
19 the limitation on expenditures established by section 2 (2), chapter \_\_,  
20 Oregon Laws 2025 (Enrolled Senate Bill 5533), for the biennium begin-  
21 ning July 1, 2025, as the maximum limit for payment of expenses from  
22 fees, moneys or other revenues, including Miscellaneous Receipts and  
23 reimbursements from federal service agreements, but excluding lottery  
24 funds and federal funds not described in section 2, chapter \_\_, Oregon  
25 Laws 2025 (Enrolled Senate Bill 5533), collected or received by the  
26 Oregon Military Department, for operations, is increased by \$195,000,  
27 for costs of bond issuance.

28 **“SECTION 37.** Notwithstanding any other provision of law, the  
29 General Fund appropriation made to the Department of State Police  
30 by section 1 (5), chapter \_\_, Oregon Laws 2025 (Enrolled House Bill

1 5029), for the biennium beginning July 1, 2025, for Bond Debt Service,  
2 is increased by \$1,283,762, for debt service.

3 **“SECTION 38.** Notwithstanding any other law limiting expenditures,  
4 the limitation on expenditures established by section 2 (4), chapter \_\_\_,  
5 Oregon Laws 2025 (Enrolled House Bill 5029), for the biennium begin-  
6 ning July 1, 2025, as the maximum limit for payment of expenses from  
7 fees, moneys or other revenues, including Miscellaneous Receipts, but  
8 excluding lottery funds and federal funds, collected or received by the  
9 Department of State Police, for the office of the Superintendent,  
10 Support Services and Criminal Justice Info Services, is increased by  
11 \$121,814, for costs of bond issuance.

12 **“SECTION 39.** Notwithstanding any other provision of law, the  
13 General Fund appropriation made to the Oregon Public Defense Com-  
14 mission by section 1 (12), chapter \_\_\_, Oregon Laws 2025 (Enrolled  
15 House Bill 5031), for the biennium beginning July 1, 2025, for capital  
16 debt service and related costs, is increased by \$2,392,222, for debt ser-  
17 vice.

18 **“SECTION 40.** Notwithstanding any other law limiting expenditures,  
19 the amount of \$145,219 is established for the biennium beginning July  
20 1, 2025, as the maximum limit for payment of expenses from fees,  
21 moneys or other revenues, including Miscellaneous Receipts, but ex-  
22 cluding lottery funds and federal funds, collected or received by the  
23 Oregon Public Defense Commission, for the Administrative Services  
24 Division, for costs of bond issuance.

25 **“SECTION 41.** Notwithstanding any other law limiting expenditures,  
26 the amount of \$13,769,781 is established for the biennium beginning  
27 July 1, 2025, as the maximum limit for payment of expenses from fees,  
28 moneys or other revenues, including Miscellaneous Receipts, but ex-  
29 cluding lottery funds and federal funds, collected or received by the  
30 Oregon Public Defense Commission, for the Administrative Services

1 Division, for a financial case management system.

2 **“SECTION 42. Notwithstanding any other law limiting expenditures,**  
3 **the limitation on expenditures established by section 2 (1), chapter \_\_,**  
4 **Oregon Laws 2025 (Enrolled House Bill 5012), for the biennium begin-**  
5 **ning July 1, 2025, as the maximum limit for payment of expenses from**  
6 **fees, moneys or other revenues, including Miscellaneous Receipts and**  
7 **including reimbursements from federal service agreements, but ex-**  
8 **cluding lottery funds and federal funds not described in section 2,**  
9 **chapter \_\_, Oregon Laws 2025 (Enrolled House Bill 5012), collected or**  
10 **received by the Judicial Department, for operations, is increased by**  
11 **\$35,000, for costs of bond issuance.**

12 **“SECTION 43. Notwithstanding any other law limiting expenditures,**  
13 **the amount of \$2,500,000 is established for the biennium beginning July**  
14 **1, 2025, as the maximum limit for payment of expenses from the**  
15 **Oregon Courthouse Capital Construction and Improvement Fund es-**  
16 **tablished by section 64, chapter 723, Oregon Laws 2013, for the project**  
17 **costs for the Morrow County Courthouse.**

18 **“SECTION 44. Notwithstanding any other law limiting expenditures,**  
19 **the amount of \$2,500,000 is established for the biennium beginning July**  
20 **1, 2025, as the maximum limit for payment of expenses from the**  
21 **Oregon Courthouse Capital Construction and Improvement Fund es-**  
22 **tablished by section 64, chapter 723, Oregon Laws 2013, for local**  
23 **matching funds for the project costs for the Morrow County Court-**  
24 **house.**

25 **“SECTION 45. Notwithstanding any other provision of law, the**  
26 **General Fund appropriation made to the Department of Environ-**  
27 **mental Quality by section 1 (2), chapter \_\_, Oregon Laws 2025 (En-**  
28 **rolled Senate Bill 5520), for the biennium beginning July 1, 2025, for**  
29 **water quality, is increased by \$999,684, for service delivery related to**  
30 **housing production.**

1       **“SECTION 46. Notwithstanding any other law limiting expenditures,**  
2 **the limitation on expenditures established by section 2 (4), chapter 452,**  
3 **Oregon Laws 2023, for the biennium ending June 30, 2025, as the max-**  
4 **imum limit for payment of expenses from fees, moneys or other reve-**  
5 **nuues, including Miscellaneous Receipts, the proceeds of bonds for the**  
6 **Orphan Site Account and federal funds from congestion mitigation and**  
7 **air quality grants, drinking water protection, laboratory accreditation**  
8 **and woodstove grants and for smoke monitoring laboratory services,**  
9 **but excluding lottery funds and federal funds not described in section**  
10 **2, chapter 452, Oregon Laws 2023, collected or received by the Depart-**  
11 **ment of Environmental Quality, for agency management, is increased**  
12 **by \$810,780, for cybersecurity.**

13       **“SECTION 47. In addition to and not in lieu of any other appropri-**  
14 **ation, there is appropriated to the State Forestry Department, for the**  
15 **biennium beginning July 1, 2025, out of the General Fund, the amount**  
16 **of \$7,000,000, for deposit into the Landscape Resiliency Fund estab-**  
17 **lished under ORS 477.502.**

18       **“SECTION 48. Notwithstanding any other law limiting expenditures,**  
19 **the limitation on expenditures established by section 2 (4), chapter \_\_,**  
20 **Oregon Laws 2025 (Enrolled Senate Bill 5521), for the biennium begin-**  
21 **ning July 1, 2025, as the maximum limit for payment of expenses from**  
22 **fees, moneys or other revenues, including Miscellaneous Receipts and**  
23 **including federal funds from the United States Forest Service for fire**  
24 **protection and for research projects, but excluding lottery funds and**  
25 **federal funds not described in section 2, chapter \_\_, Oregon Laws 2025**  
26 **(Enrolled Senate Bill 5521), collected or received by the State Forestry**  
27 **Department, for forest resources, is increased by \$7,000,000, for the**  
28 **Landscape Resiliency Fund established under ORS 477.502 for imple-**  
29 **menting ORS 477.503.**

30       **“SECTION 49. Notwithstanding any other law limiting expenditures,**

1 the limitation on expenditures established by section 2 (4), chapter \_\_\_,  
2 Oregon Laws 2025 (Enrolled House Bill 5026), for the biennium begin-  
3 ning July 1, 2025, as the maximum limit for payment of expenses from  
4 fees, moneys or other revenues, including Miscellaneous Receipts, but  
5 excluding lottery funds and federal funds, collected or received by the  
6 State Parks and Recreation Department, for direct services, is in-  
7 creased by \$73,123, for site interpretation about the Ruble House and  
8 improvements.

9 **“SECTION 50.** Notwithstanding any other law limiting expenditures,  
10 the amount of \$2,100 is established for the biennium beginning July 1,  
11 2025, as the maximum limit for payment of expenses from fees, moneys  
12 or other revenues, including Miscellaneous Receipts and Medicare re-  
13 cepts and including federal funds for indirect cost recovery, Social  
14 Security Supplemental Security Income recoveries and the Child Care  
15 and Development Fund, but excluding lottery funds and federal funds  
16 not described in this section, collected or received by the Department  
17 of Human Services, for State assessments and enterprise-wide costs,  
18 for debt service.

19 **“SECTION 51.** Notwithstanding any other law limiting expenditures,  
20 the limitation on expenditures established by section 2, chapter 472,  
21 Oregon Laws 2023, for the biennium ending June 30, 2025, as the max-  
22 imum limit for payment of expenses from fees, moneys or other reve-  
23 nues, including Miscellaneous Receipts, and including federal Older  
24 Americans Act funds received from the Department of Human Ser-  
25 vices, but excluding lottery funds and federal funds not described in  
26 section 2, chapter 472, Oregon Laws 2023, collected or received by the
