SUBJECT: Written Testimony in Support of HB 2948

Chair Nosse, Vice-Chairs Javadi and Nelson, and all Members of the Committee:

Multnomah ESD's School Health Services department serves almost 100,000 students across 8+ districts in the Multnomah County region. We employ over 75 nurses and over 80 School Health Assistants to support our partner districts in removing health-related barriers to education. We are pleased that our department has a 50-year history of providing these necessary services. We strongly support **HB 2948**, which will ensure that only a registered nurse may supervise a nurse in a school setting when it comes to nursing practice.

At MESD, we are fortunate to have an infrastructure that supports effective school nursing practice, including a team of Nurse Administrators that oversee our population-based, complex needs and 1:1 nurses. However, not every nurse practicing in the K-12 setting across the state of Oregon has this luxury. Many are a team of 1 and are supervised by an education professional instead of a health professional. While this can work for typical employment expectations (attendance, interactions with others), it can be a danger when it comes to having a non-nurse providing oversight of nursing practice. Education professionals do not have the background and/or training necessary to evaluate nursing judgement. **HB 2948** will ensure that this potentially dangerous practice doesn't continue.

In my first position practicing nursing in Oregon schools, I spent 9 years as the primary nurse for a district of about 3,000 students. During those 9 years, I was supervised by a range of education administrators - School Principal, Superintendent, Human Resources Director. While they were able to support my role in relation to how it fit into the educational goals, I often had to seek outside guidance to support my nursing practice.

In conclusion, **HB 2948** would provide critical safeguards for students and nurses practicing in the K-12 setting by ensuring that supervision of clinical nursing practice is not done by those without
