In the school setting, nurses are responsible for critical health decisions that affect student well-being. Supervision by someone who does not fully understand nursing protocols, clinical judgment, and decision-making processes could compromise the safety and quality of care provided. Nurse supervisors are uniquely equipped to identify areas for improvement and support their peers in maintaining and enhancing care standards.

4. Fostering Professional Growth

Nurses benefit from constructive feedback and mentorship provided by supervisors who share their professional background. Nurse-led supervision fosters an environment of mutual respect and understanding, allowing for tailored guidance and

professional development that aligns with the unique challenges and responsibilities of school nursing.
