My name is Je Amaechi, and I am in House District 43. I am a member of my local Neighborhood Emergency Team (NET) and the organizing director at Unite Oregon. I am writing to express my strong support for HB 3170, because we need the critical funding offered through the Resilience Hubs and Networks grant program.

The urgency of this funding cannot be overstated. This year alone, we have witnessed the devastating impacts of climate change through the catastrophic floods in North Carolina and the devastating fires in Los Angeles. My father actually lives in Western North Carolina, the area that was severely affected by the recent floods. For the 10 years i've lived here, Oregon has faced its own series of severe disasters. These events have shown us the critical need for preparedness and resilience, particularly as we anticipate the inevitability of 'the Big One'—a major Cascadia earthquake that could have catastrophic consequences for our region.

As a member of NET, I have seen firsthand the importance of community preparedness. NET team members are often deployed during weather emergencies, but our efforts were often hampered by a lack of resources and infrastructure.

The Resilience Hubs and Networks grant program has the potential to make a significant difference by providing the resources needed to build stronger, more resilient communities. By funding these hubs, we can ensure that communities have the tools and infrastructure they need to respond effectively to disasters.

HB 3170 is essential to continue this important work. By providing additional funding, we can support more communities in building resilience against the increasing threats of climate change.
