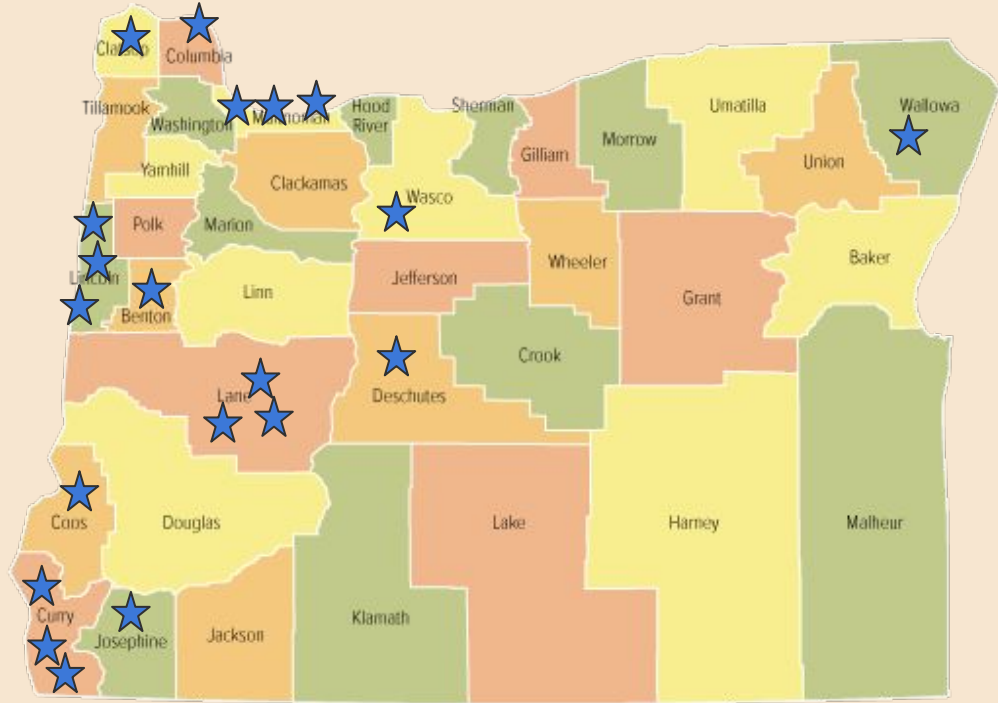

# Food Hub Worker Safety & Infrastructure Grant Round 1

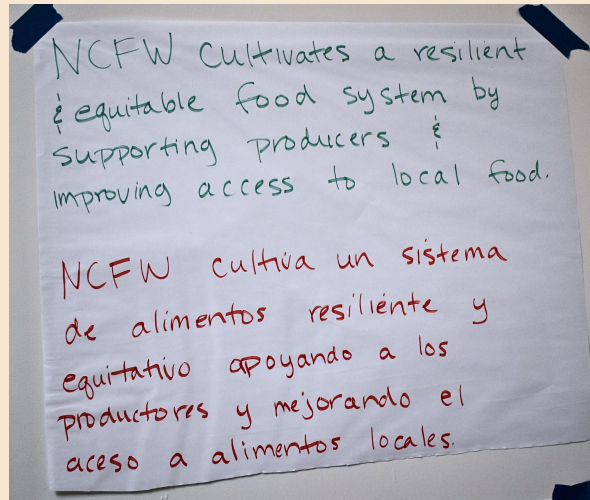
- 20 Food Hubs received awards

# In 2024, the Food Hub Network

- Launched a staff development program aimed at improving leadership skills and providing mentorship for food hub program delivery staff.
- Launched a needs assessment and action planning with for-profit hubs that participate in the network.
- Expanded Worker Safety site visit evaluations to 8 hubs.

# Food Hub Worker Safety and Infrastructure Grant

## Report on Grant Distribution/Awards for Round One

### Program Overview:

During the 2023 Oregon Legislative Session, the legislature allocated \$1.5 million to the Oregon Community Food Systems Network (OCFSN) for the Food Hub Worker Safety & Infrastructure Grant Program. This funding was initially included in the expansive 2023 Bipartisan Drought Relief and Water Security Package (BiDRAWS) and was advocated for by a broad cross-section of OCFSN members. Late in the session, the funding was moved to the Budget Reconciliation Bill (Senate Bill 5506) and passed at the end of session.

This document provides the details and outcomes from the first round of program grant funding. For the two years, the Food Hub Grants program is investing \$1,000,000 in Food Hub Worker Safety and Infrastructure Grants, \$300,000 in Food Hub Network Technical Assistance Investment, and \$150,000 in program administration. With the guidance and support of local food hubs and help from four members involved in Oregon's local food systems, OCFSN distributed \$696,591.43 in its first round of state funding through the Food Hub Worker Safety and Infrastructure Grant Program to 20 Oregon food hubs and regional food system infrastructure to support building local economies and disaster resilience.

### Grant Program Goals:

- To create an accessible grant program that provides resources to improve safety and capacity of food hubs in Oregon.
- To create a grant program that prioritizes food hubs building local economies and disaster resilience:
  - Through the grant application review rubric, we will prioritize hubs located and/or serving a rural community and
  - hubs led by and serves Black, Indigenous and People of Color (BIPOC), immigrant, and refugee communities
  - Hubs that have limited access to grant funding & have demonstrated commitment to delivering on OCFSN mission: strengthening local and

regional food systems to deliver better economic, social, health, and environmental outcomes across the state.

- Direct individual support to grant applicants to strengthen applications.
- Robust reporting and testimonial gathering to show impact of this funding on regional and community food systems in Oregon.

## **By the Numbers:**

## **Applications:**

The Worker Safety Grants and Infrastructure Grants each have a small and a large funding categories. Having two grant pools helps us meet two granting priorities: get safety and infrastructure dollars to as many hubs as possible **and** include larger grants that will have a greater impact on individual operations.

- Worker Safety Grants: Improving worker safety equipment & infrastructure.
  - Low Barrier: awards up to \$4,999
  - Capacity Building: awards between \$5,000-\$25,000

- Infrastructure Grants: Strengthening local food distribution and regional food system resilience with increased warehousing & cold storage capacity.
  - Low Barrier: awards up to \$4,999
  - Capacity Building: awards between \$5,000-\$75,000

**Eligible applications received = 37**

Award Details:

***20 Food Hubs awarded partial or full grant funding. 3 Food Hubs were awarded both Worker Safety and Infrastructure funding for a total of 23 awards***

- 17 Infrastructure grants awarded
  - 13 capacity building grants totalling **\$631,716.24** in awards
  - 4 low barrier grants totalling **\$17,876.29** in awards
- 6 Worker Safety grants awarded
  - 3 capacity building grants totalling **\$32,042.90** in awards
  - 3 low barrier grants totalling **\$14,956.00** in awards

**\$696,591.43 awarded in total**

**Food Hub Network Technical Assistance Investment:**

The Food Hub Network is investing \$300,000 of this funding over two years in statewide shared resource development and training In addition to the Infrastructure & Worker Safety grants. This investment included on-site Worker Safety evaluations and trainings (8 counties), group Worker Safety training (statewide), and investment in leadership and skill building with food hub program managers (statewide/24 regular participants), leadership training across the network (statewide/across all Oregon Community Food System Network working groups), and targeted business development support for higher volume food hubs (4 businesses).

**Testimonials and Level of Impact:**

The need for resources to expand and strengthen local food systems within each food hub was clearly identified through each application. Below are a few impact statements on how the funding will improve capacity:

*“Investing in a walk in fridge will serve as cold storage for all perishables purchased through our program. Produce and proteins purchased through our program will partially be donated to partner organization as well as be used to stock free food boxes that will be available weekly to BIPOC community members”*

*“OCFSN’s funding would greatly increase the capacity of our food hub, Oregon’s smallest, most remote food hub. Increased capacity means more people in Wallowa and Union counties accessing high-quality, nutrient dense food grown by their neighbors. It means paying local farmers and ranchers a living wage, which will inspire them to continue to work their land in a sustainable manner.”*

*“Pop up Canopy is for summer use in the fields when it is hot. Both when we are working to block out the sun’s rays and to provide cover for the delicate greens if we are not able to harvest early in the morning. As farmers, we are constantly exposed to UV to minimize the exposure keeps people safe from the heat and from developing cancer.”*

**Grant interest by food hub applications:**

We have seen significant interest and need for this grant program. For this first round there were a total of 23 projects of 46 eligible applications requesting over \$1.8 million out of the available \$700k.

- Counties represented in eligible applications but not selected: Deschutes, Coos, Multnomah, Washington, Clatsop, Lane, and Hood River
- Four of the denied applicants were nonprofits, and six were LLCs

**Awarded Food Hubs:**

The reach of local food hubs awarded is statewide, furthering our efforts to support building local economies and disaster resilience.
