## SUPPORT SJM2 SENATE COMMITTEE ON JUDICIARY FEBRUARY 6, 2025

Dear Chair Prozanski, Vice-Chair Thatcher, and Members of the Senate Committee on Judiciary,

Thank you for considering this testimony. **On behalf of the Oregon Sexual Assault Task Force (Oregon SATF), we are submitting testimony in support of SJM2**, which urges Congress to enact legislation alleviating the funding crisis in the Crime Victims Fund.

*Formed in 1999 by then Attorney General Hardy Meyers, the Oregon Attorney General's Sexual Assault Task Force (or Oregon SATF) is a statewide, nongovernmental nonprofit. Our mission is to facilitate and support a collaborative, survivor-centered approach to the prevention of and response to sexual violence. We accomplish our mission by advancing primary prevention and providing multi-disciplinary training and technical assistance to responders in Oregon and nationally.*

In 1984, Congress signed VOCA into law and created the Crime Victims Fund (CVF). VOCA funding (appropriated from the CVF) is the primary source of federal grants for victim services, including services for survivors of domestic violence, child abuse, sexual assault, human trafficking, elder abuse, and other crimes. It supports victims in some of the most high-risk scenarios who are experiencing strangulation, stalking, and an increased risk of serious injury and homicide. It also matches 75% of eligible state victim compensation funding.

**Programs across Oregon rely on VOCA funding to provide services**, including Children's Advocacy Centers, District Attorney Victim Assistance Programs (DAVAPs), Community-based Nonprofit Domestic Violence and Sexual Assault (DVSA) Programs, and Campus Sexual Assault Programs. **These grants fund vital services to survivors of domestic and sexual violence, ranging from crisis intervention to long-term healing.**

Since 2017, Oregon SATF has proudly partnered with Oregon's Department of Justice to facilitate VOCA grants for eight campus-based advocacy programs, focused on providing services for Oregon student survivors across the state. These services help ensure that Oregon students not only have compassionate, confidential care when they need it most, but assist Oregon students who experience sexual and domestic violence to stay in school, and complete their education. Now, these programs (serving over 200,000+ students in our state) are at risk of closure as continued VOCA funding cuts loom.

Additionally, these cuts threaten to decrease the already limited support services available in our state to support survivors of sexual violence, including every county-based domestic and sexual violence advocacy agency.

Bipartisan efforts are underway federally to create a long-term solution for the CVF, and your support to stabilize funding and ensure our state's ability to offer life-saving services to survivors is essential. **We know that supporting victims of crime is a nonpartisan issue, and these efforts will continue.**

**For the above reasons, we urge you to support this request to pass SJM 2 and urge Congress to pass the Crime Victims Fund Stabilization Act without delay.** Crime victims and survivors in Oregon deserve the safety and well-being that these funds afford. Organizations like ours that provide these services cannot continue delivering them without your support.
