- Road Restrictions: Limit ATV use to roads with speed limits of 45 mph or lower, except in designated areas.
- Local Control: Allow counties and municipalities to set their own regulations based on community needs.

Allowing road-legal ATVs in Oregon would provide numerous benefits, including economic growth, improved transportation options, environmental advantages, and enhanced outdoor recreation opportunities. By implementing appropriate regulations, the state can ensure safety while also supporting rural communities and businesses.
