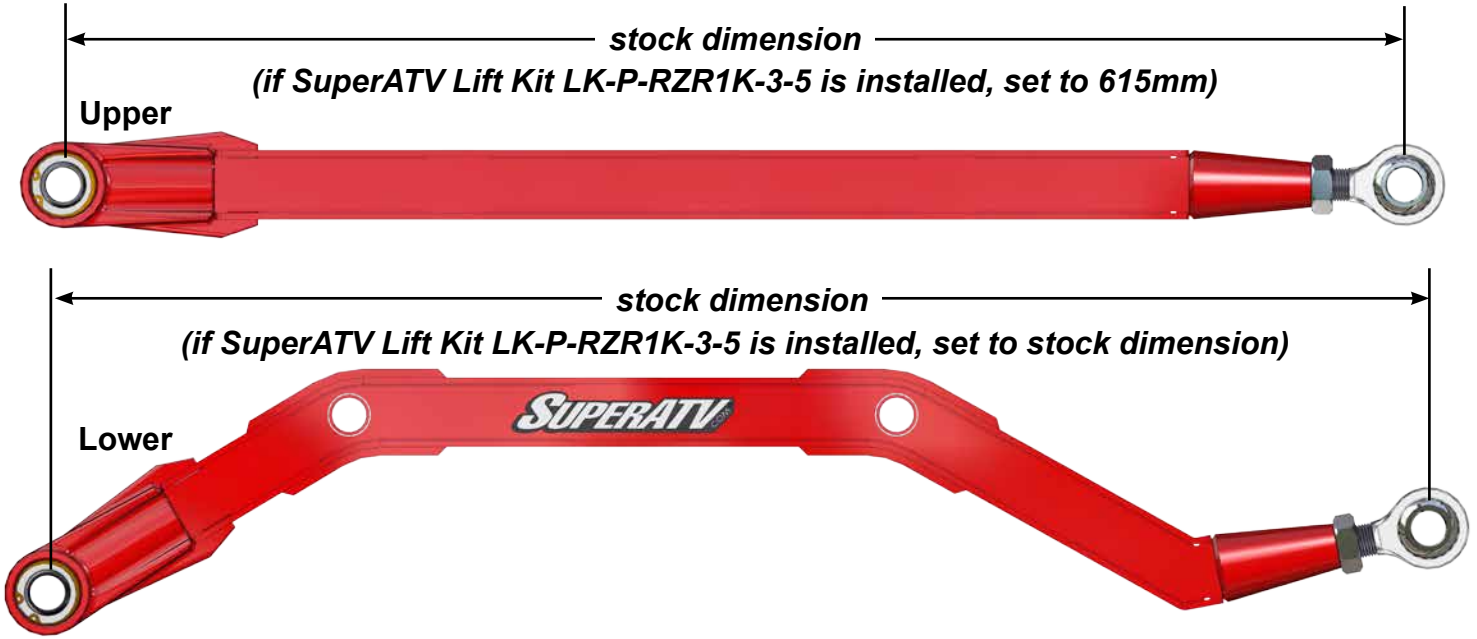
- M10 and M12 hardware, Bushings, and Misalignment Bushings are included with kit.
- Use stock RSL bolt to determine M10 or M12 installation.



Keep all stock hardware removed from machine.

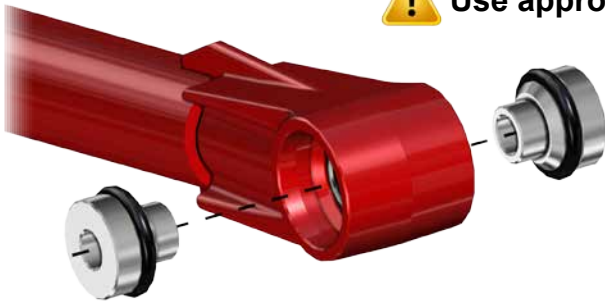


Measure eye-to-eye distances on stock RSL's and transfer dimensions to new RSL's.



- Install (2) Misalignment Bushings into each RSL as shown.

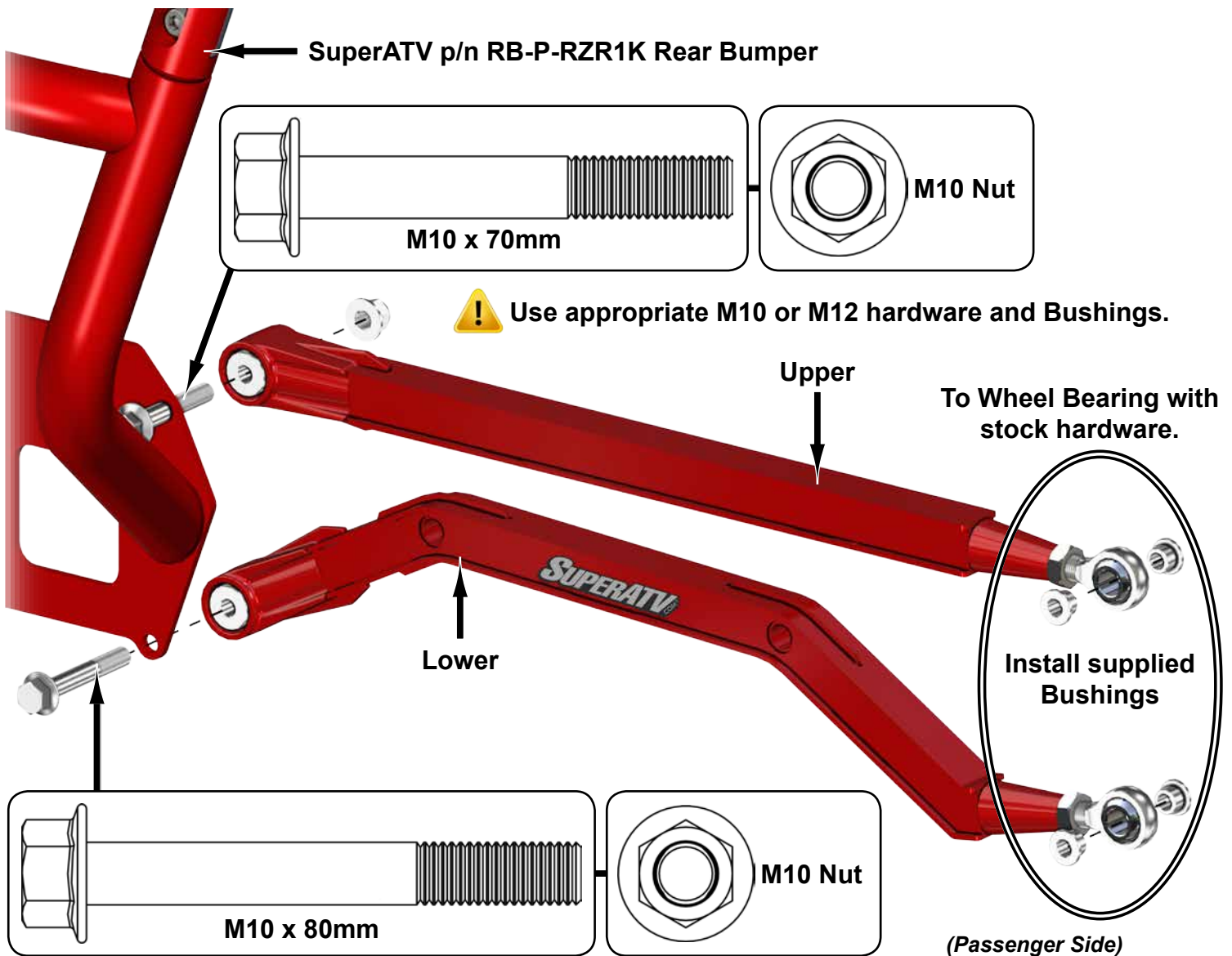
! Use appropriate M10 or M12 Misalignment Bushings.



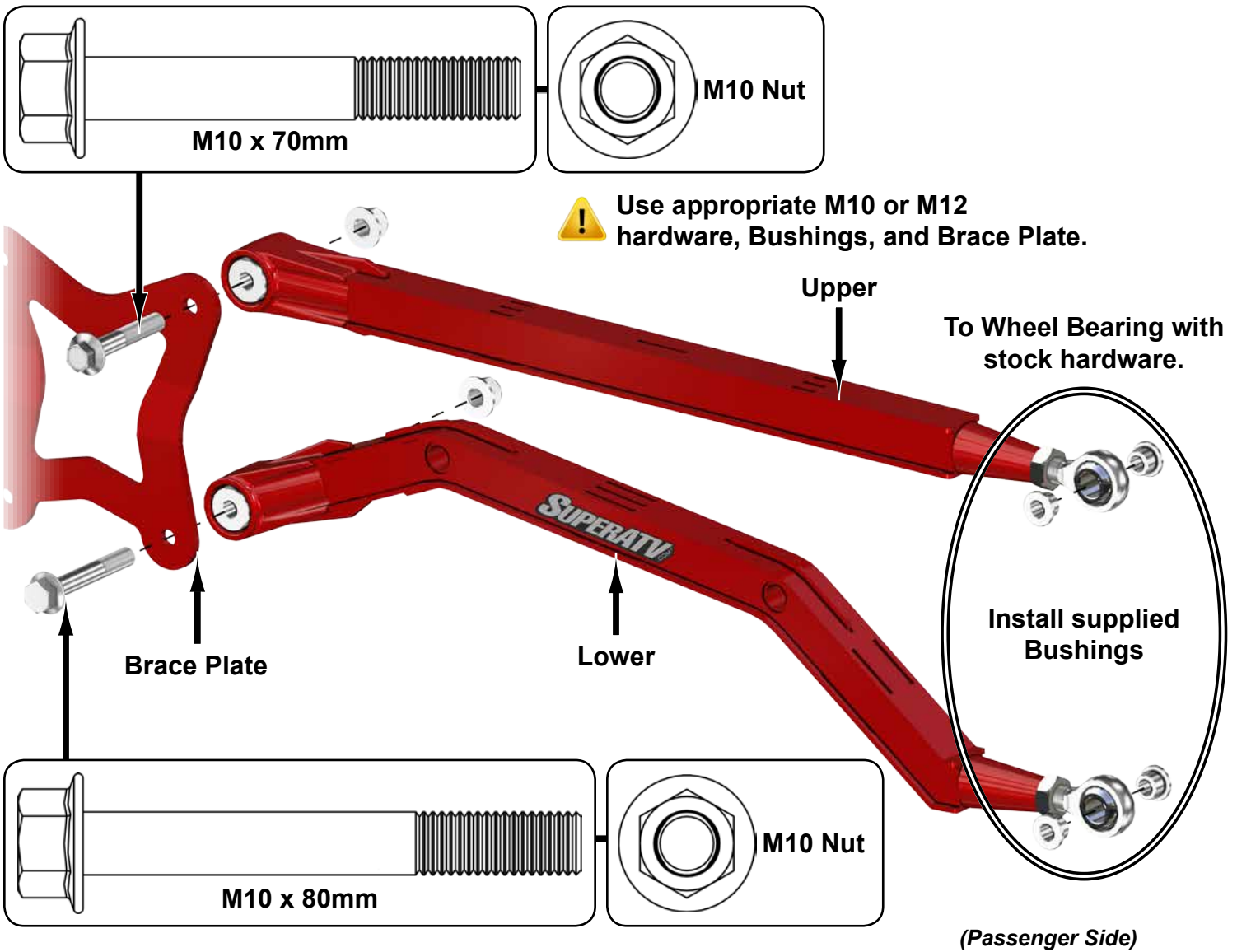
Installation: *passenger side shown.*

- If machine has SuperATV RB-P-RZR1K Rear Bumper use "Install Option A".
- Machines without a Rear Bumper use "Install Option B"; see following page.
- Repeat for opposite side. Tighten hardware completely.

Radius Arms Adjustment:

- If Wheels and Axles do not rotate freely, equally adjust Radius Arms "out" in small increments.
- Tighten hardware completely.
