Legislative Testimony on the Childcare Crisis in Support of HB3011	

Good morning, Chair Hudson, vice chairs Fragala and Harbick, and members of the committee,

My name is Heather DeSart, and I am the Executive Director of Northwest Oregon Works, the Local Workforce Development Board serving Benton and Lincoln Counties.
