To the Members of the House Committee on Behavioral Health and Health Care,

I am writing to express my strong support for HB 3439, which ensures fair reimbursement for naturopathic physicians who provide essential healthcare services. As a patient who has directly benefited from naturopathic care, I can personally attest to the value these providers bring to Oregon's healthcare system. For years, I struggled with chronic knee pain and persistent throat phlegm, seeking help from various conventional providers with little success. It was only after working with a licensed naturopathic physician that I finally experienced real, lasting improvements. Their comprehensive, patient-centered approach addressed not just my symptoms but the root causes of my condition, leading to better long-term health outcomes. Unlike rushed appointments in conventional settings, my naturopathic doctor took the time to listen, educate, and develop a personalized treatment plan that worked for me.

Despite their rigorous medical training and proven effectiveness, naturopathic physicians continue to face systemic reimbursement barriers, making it difficult for patients to access their care. This violates the ethical principles outlined in the Hippocratic Oath, which states that healthcare providers should: Do No Harm: Physicians must prioritize patient well-being above all else. Practice with Integrity: Uphold ethical medical standards and honesty in treatment. Protect Patient Confidentiality: Safeguard patient trust and privacy. Commit to Lifelong Learning: Continuously advance medical knowledge and care. Respect Human Life: Treat all patients with compassion, dignity, and fairness. By passing HB 3439, Oregon will take a critical step toward fixing our broken healthcare system and ensuring that patients can access the providers who best meet their needs. We must put an end to the corrupt financial structures that prioritize insurance company profits over quality patient care. This is the year for change. The current system is not working, and we can no longer pretend that it is.
