PELL GRANT STATUS

Arduous federal requirements and approval process.

- Oregon is ahead of most states and is asked for guidance.
- It takes approximately one year to complete the entire
 U.S. Department of Education application process.
- We thank our college partners for their dedication and perseverance.

Central Oregon Community College

- 1st in Oregon and 3rd in nation to complete U.S. Dept. of Education Pell Grant requirements
- Successfully piloted the <u>online FAFSA application process</u> at DRCI, which can now be expanded to other DOC institutions
- Portland State University 2nd in Oregon to complete the program requirements
- Portland Community College Ready to complete last application step
- Chemeketa, Treasure Valley, and Eastern Oregon University — in 2nd step of application process (accreditation)

WHAT HAVE WE LEARNED

- Frequent communication between all parties is essential.
- Onsite staffing to oversee and assist AICs in computer labs as well as to manage the programs and provide the colleges with a central point of contact is paramount to success.
- Coordination and prioritization of AIC Net enhancements. Enhancement Request Governance Committee (ERGC) formed to prioritize highest needs.
- Whitelisting online courses is difficult and labor-intensive
- Installing Wi-Fi inside prisons is more difficult than anticipated.

IMPACT OF EDUCATION ON RECIDIVISM

According to a recently updated study by the RAND Corporation:

- AICs participating in correctional education are 28% less likely to recidivate than those who do not.
- AICs participating in postsecondary education in prison are **48%** less likely to recidivate than those who do not.

Oregon Example: Chemeketa Community College

- Operated a prison college program since 2007.
- 2018, 42 students graduated with a cumulative GPA of 3.8.
- 256 graduates, 6% recidivism rate.
