I OPPOSE [HB 3527] It will not fix the problem for which it was created. When is Oregon going to pay off its' disgraceful indebtedness.

From the TEXT of [HB 3527], "...SECTION 1. (1) The Public Drinking Water and Sewer Ratepayer Assistance Fund is established in the State Treasury, separate and distinct from the General Fund.

...(2) Moneys in the fund are continuously appropriated the Housing and Community Services Department for the purposes set forth in subsection (3) of this section.

...(3) The department shall provide grants from moneys deposited in the fund to qualified organizations to distribute water and sewer bill payment assistance to low-income residential households.

...(a) Nonprofit community-based organizations, including but not limited to housing authorities and community action agencies;

...SECTION 2. In addition to and not in lieu of any other appropriation, there is appropriated to the Housing and Community Services Department, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$11,000,000, for deposit in the Public Drinking Water and Sewer Ratepayer Assistance Fund established under section 1 of this 2025 Act."

*** [\$11,000,000] GENERAL FUND Taxpayer dollars (including my taxpayer dollars) is requested to further the unsustainable "Welfare State?"

***It is past time for Municipalities to enact serious and prolonged sewer hook-up moratoriums.
