I OPPOSE [SB 339].

From the TEXT of [SB 339], "...SECTION 1. (1) In addition to and not in lieu of any other appropriation, there is appropriated to the State Forestry Department, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$3,100,000, which shall be placed into the State Forestry Department Account and expended for carrying out an integrated pest management program under ORS 527.310 to 527.370 to combat the plant disease Sudden Oak Death.

(2) The department shall expend \$50,000 of the moneys appropriated under this section as a block grant to assist the Association of Oregon Counties with establishing and operating a task force to encourage and coordinate county integrated pest management programs to combat Sudden Oak Death..."

\*\*\*The proposed GENERAL FUND allocation of [\$3,100,000] to the State Forestry Department may be necessary in the near future but not now.

\*\*\*What work have all those OSU Extension Offices done with respect to "Integrated Pest Management?"

\*\*\*The [\$50,000] block grant for the Association of Oregon Counties siphoned off the [\$3,100,000] GENERAL FUND allocation above to combat the "Sudden Oak Death" disease is laughable and utterly wasteful.

\*\*\*Yamhill County colloquially referred to as "Scam-Hill" County has a variation of "Sudden Oak Disease" that kills Oak Trees practically within one day.
