Beginning September 27, 2018, with a TPO obtained with knowingly false accusations, I have been alienated from my children. From that day until October 17, 2021 I would take time each night and search for any trace of my children through death notices and obituaries. Then October 17, 2021 I signed for a packet containing items from family court including a petition that has 5 allegations against me?? A notice that said I was to appear at a final hearing in October 25, less than a week after I received the notice. Two required notices of contact from 2 different people. Both notices were dates AFTER the petition for dependency was filed. I think I may be the only person to ever say how happy I was to see those papers. We did just shelf a few years in a global pandemic that was more deadly for children and elderly... But had I known then the experience I would suffer, I would not have been so happy.

Not only did the papers I receive have I little information, they were also the only documents I would ever see. And though the timestamp, or postmark, was dated the 14th of October... Some of the papers were dated differently. I would say illegally. A protection order on files and the notice are signed as served on October 7,... But were not even mailed until the 14th.. a week later. The contact notices were dated September 20 and September 29. One of those has no mention of a petition, a hearing and neither tell me what has happened. Every phone number I found I called. None of those hundreds of calls were ever returned. It gets worse. I not only was not notified of the courtdate ever, but not notified of review or of the removal, twice, and placement into fostercare. I never had an interview or assessment. Never had UCCJEA enacted, ICPC OR PKPA. NOBODY ASKED ABOUT THE PRIOR WASHINGTON ORDER INTO AFTER THEY HAD SOMEHOW REOPENED IT AFTER EXPIRING IN 2020 AND THEN CREDITING MY EX FOR MORE THAN \$30,000.00 OF ARREARAGES AND THE ATTORNEY THEY APPOINTED, I'LL JUST SAY INEFFECTIVE BUT PLEASE KNOW NOT A SINGLE ITEM WAS FILED ON MY BEHALF. SHE SEEMED EITHER IGNORANT OF THE ACTUAL LAWS OR SIMPLY WAS IN COLLUSION IN THE COMPLETE DEPRIVATION OF MY RIGHTS. NOT EVEN DEPRIVATION.. IF ANYTHING I'D CAN IT THE INTENTIONAL DECEPTION AND BEHAVIOR INTENDED TO PREVENT EVER BEING ABLE TO SPEAK OR PARTICIPATE IN COURT. NO BEHAVIOR OBSERVED. NO THREAT OF HARM POSSIBLE OR OBSERVED. NO NEXUS AND NO RELEVANT INFORMATION INVOLVED ME IN ANY WAY. YET THE JUDGE FOUND THE ALLEGATIONS TRUE WITH NO HEARING NO EVIDENCE NO DUE PROCESS WHATSOEVER AND THEN TO KEEP MY VOICE SILENT JUDGE LOVE CUTS ME OFF, CALLS A RECESS AND CALLS THE POLICE TO ISSUE A CITATION FOR CONTEMPT AND THEY ESCORT ME OUT AFTER THAT IS JUST CONSTANT

THREAT OF ARREST ON FICTIONAL WARRANTS THAT SOMEHOW JUST APPEAR 6 to 7 years after I left Oregon in a place I don't think actually exists.....I can't say the agency or the court is corrupt. I can say that Jennifer Whalen and Tonya Huff of Eugene cps have conspired with the JUDGE along with my ex, to eliminate a father that did nothing wrong but when you can make up things I'm blamed and punished. Check the transcripts if you like ... You might hear me give my address 6 it more times, and that's all. I've never been two the allegations. Never asked anything or allowed to participate without the JUDGE immediately cutting me off.
