Dear Co-Chairs Frederick and Levy and members of the Committee:

I'm writing on behalf of the Oregon Climate and Agriculture Network (OrCAN) to express strong support for \$5M in OWEB's budget, for renewal of the Natural and Working Lands (NWL) Fund. The Fund, which is included in the Governor's recommended budget at \$5M, provides incentives and technical support to help landowners, land managers, environmental justice communities, and Tribes adopt practices that support natural climate solutions on Oregon's natural and working lands, including farms and ranches.

In addition to our support, *twenty-five farms, ranches, vineyards and agricultural businesses have endorsed the NWL funding request.* See the list of endorsing producers below.

The NWL Fund invests in *existing* programs and projects within state agencies, including programs that existed in statute without funding. Among other things, this funding launched the State's new grant program providing payment for agricultural practices with ecosystem services including carbon sequestration, water quality and habitat benefits.

Continuity of this funding is critical! When funding is available one year and not the next, interest in the programs decreases, and it becomes difficult for farmers and community organizations to anticipate what will be available and take best advantage of it.

Farms and ranches are on the front lines of climate change. The same agricultural practices that mitigate climate change help farms and ranches be more resilient to climate impacts by managing wildfire risk, improving water infiltration and storage, increasing biodiversity, and protecting crops against pests and diseases.

We urge you to support the inclusion of the \$5M investment in the NWL Fund in OWEB's budget for the 2025-2027 biennium.

We also support inclusion of the Climate Resiliency staff position proposed in OWEB's budget, and included in the Governor's Recommended Budget. This position is leading engagement with communities and Tribes on how best to utilize and distribute OWEB's NWL Funds, and has been instrumental in collaboration with other implementing agencies.

We are also supportive of, and urge your support for, the request for funding the Oregon Agricultural Heritage Program (OAHP) in OWEB's budget. OAHP protects working ranch and farmlands for their agriculture and natural resource values through four grant programs including conservation easements and conservation management plan grants.
