Continued funding will ensure the transition from pilot projects to established, scalable efforts that yield lasting economic and environmental returns.

I urge you to prioritize the Natural and Working Lands Fund in the 2025-2027 biennium budget. This investment is not just an environmental imperative but a strategic economic decision that will support Oregon's agricultural and forestry sectors while safeguarding our communities from climate-related disruptions.
