Re: [HB 3103](#) with [-1 amendment](#) – Timber Harvest on State Forestland – OPPOSE

The League of Women Voters of Oregon (LWVOR) believes that “*a full accounting of all costs, including cumulative ecological impacts of timber harvests and other forest uses must be considered in forest activity decisions.*”

Under current law in [ORS 530.050](#), “the State Forester shall manage State forestlands...so as to secure the greatest permanent value of those lands to the state...” and “do all things and make all rules, not inconsistent with law, necessary or convenient for the management, protection, utilization and conservation of the lands.” HB 3103-1 would greatly restrict that authority by requiring the State Forester to set inflexible sustainable timber harvest volume levels by rule, for a ten-year period with strict annual targets, that if not met would be added to the following year’s harvest levels. Failing to do so, the Department of Forestry would be subject to civil lawsuits. This bill puts managing forests for timber volume above all other forest values for “greatest permanent value,” such as for recreation, ecological services and carbon sequestration and storage. The State Forester can already set rules, but this bill would make it so that once forest level volumes are set by rule, they become law and cannot be changed without significant effort.

The Board of Forestry approved the **Climate Change and Carbon Plan (CCCP)** after careful deliberation and legal delay, and this bill would undermine the goals of that plan to reduce greenhouse gas emissions in Oregon to combat climate change, as well as those of the [Vision for Oregon’s Forests](#), which the LWVOR has supported. We urge the Committee not pass this bill which would tie the hands of the State Forester to react as conditions change. The computer modeling for various forest management outcomes and trade-offs that is being run now should inform decision-making in any changes in forest management on state lands. Our forests have more value to Oregonians than as just a commodity sold to produce revenue.
