Members of the House Committee on Rules, I am writing today in opposition of this ridiculous bill brought forward by Representative Neron and others.

"Research shows that students who participate in extracurricular activities are more engaged in school, have higher attendance, and are more likely to graduate." and

"Research shows that students aged 16 and 17 have the same civic education, political skills, and interests as their 18-year-old classmates, who can vote."

They provide no citations because there is no such research. These activists are trying to manipulate you and others to further their radical transformation of our

school system and society. Trust me, I know better than most that our state legislature lacks the ability to validate research claims being made. As Rep Neron personally can attest to, I've spoken with her at length about this. I thought she was onboard with ensuring our education system was successful, which starts with leading with research-based programs and policies, but it appears she's bought the snake oil this latest group of NGOs is peddling.
