This partnership will serve as a symbol of solidarity and a practical step toward supporting Ukraine's economic and social

development during this critical time.

I strongly urge you to support SCR 23 and demonstrate Oregon's steadfast dedication to global partnerships, the defense of freedom, and Ukrainian people worldwide.
