SUBJECT: Support for SB 599

Chair Prozanski, Vice-Chair Thatcher, and Members of the Committee,

My name is Ali King and I am the Policy and Advocacy Director for Our Children Oregon (OCO), a statewide organization that advances equitable policies, data and research, and whole-child advocacy. The Children's Agenda, convened annually by OCO, brings together more than 135 organizations statewide to create a holistic legislative agenda dedicated to improving the wellbeing of Oregon's children, youth, and families. **SB 599 is prioritized in the 2025 Children's Agenda and has strong and broad support from our partner organizations across Oregon.**

Throughout my career as a Congressional Caseworker and Policy and Advocacy Director, I have seen firsthand the contributions immigrants and refugees make to our communities and the challenges they face. SB 599 addresses a critical gap in our state's housing laws by prohibiting landlords from inquiring about or discriminating against tenants based on their immigration status. Stable housing is foundational to economic security, public health, and overall well-being, yet many immigrant families experience unjust housing discrimination, leading to increased vulnerability to eviction, homelessness, and exploitation.

In Oregon, 21% of children come from immigrant families and 29% of children in immigrant families have resident parents that are not US citizens as of 2022¹. A significant portion of Oregon's youth are vulnerable to increased housing instability without this bill. In Oregon, housing instability is linked to poor physical and mental health outcomes, which leads to various other issues, including lower rates of attendance in school and declining educational outcomes for youth.

While most housing providers already adhere to best practices and do not discriminate on the basis of citizenship or immigration status, passage of the bill ensures that these principles are codified in our state statutes and sends a protective and inclusive message to our communities. Oregon has a long history of promoting inclusivity and protecting vulnerable populations and this bill is a natural extension of those values.

We appreciate the work you do for Oregon's families and children.

We strongly urge you to support SB 599 to ensure that all Oregonians have access to fair housing.
