Written Testimony of Michael McNally Ways and Means Education Subcommittee Department of Early Learning and Care Budget Hearing March 6, 2025, 1:00pm

My name is Mike McNally, and I am a Director of the Willamette Valley Wine Foundation (WVWF), a member of the Children's Institute Advocacy Committee, and an Executive Committee member of the *Primeros Pasos Early Childhood Education and Care Consortium.* My testimony is on behalf of these organizations and the agricultural stewards that nurture Oregon's specialty crops.

I am advocating for additional funding for the Department of Early Learning and Care (DELC), and specifically for the Employment Related Day Care Program (ERDC).

Investments in Early Childhood Education and Care (ECEC) create unparalleled benefits:

- Future Success of Children, it sets the foundation for literacy, ¹
- Economic stability for families, it supports two family incomes, and
- Support of businesses it creates an expanded workforce.

ECEC is a socially profitable investment. Every dollar invested provides a lifetime benefit of \$3 to \$7 and a tax-adjusted internal rate of return (IRR) that ranges from 8% to 18%. ² This is one of the best investments the Oregon Legislature can make.

The lack of ECEC resources has profound economic and social consequences. Businesses cannot function if their workforce does not have early childhood care. In addition, lack of affordable care limits parent's, especially mothers, ability to provide for their families. Oregon's highest poverty group is families with children under five. Child poverty is the strongest indicator of adverse future health and outcomes. Increasing the quantity of quality early childhood educators, and programs, will create opportunities for families and mitigate child poverty.

The benefits of ECEC can only be realized if we significantly expand the early childhood educator workforce and associated programs. Recognizing this, the WVWF partnered with CAPACES Leadership Institute and Oregon Child Development Coalition to establish the *Primeros Pasos Consortium*. Our team includes the Mid-Willamette Child Care Resource & Referral and Marion-Polk and Yamhill CCO Early Learning Hubs.

Over the past two years *Primeros Pasos* has provided leadership to:

- License 17 Family Child Care Home providers with another 15 in progress,
- Sponsor two cohorts in the Clackamas Community College Spanish based
 Associate Degree program for Early Childhood Education and Family Studies,
- Develop a BOLI Certified Apprenticeship Program, and
- Develop Spanish based learning resources for the Family Child Care Homes.

DELC's ERDC program is crucial for the economic viability of the incremental *Primeros Pasos* Family Child Care Homes, and their teacher/providers. Unfortunately, there is currently a wait list for ERDC benefits. In addition, families that have been enrolled in the program are not being connected with eligible providers.³
