Re: SB 77 and SB 78

Chair Golden and Committee Members:

Please Support SB 77 and SB 78. We have to stop this War on Oregon's farm and forest lands. Check the facts and the details. Opponents are wrong.

What does SB 77 not do?

Home Occupations of any kind are still allowed as long as they are "accessory to the residential use".

What does SB 77 do?

It limits businesses that have nothing to do with the use of the property as a residence like stand alone hotels and restaurants.

It protects farm land for farming and neighboring farms from harm.

What does SB 78 not do?

It does not prevent farmers who actually have real farms from having a house of any size through several other ways to get dwellings.

It does not prevent a farmer from replacing a 3000 sq ft old farm house with a 3300 sq ft home (110% of existing dwelling).

What does SB 78 do? It prevents Non farm owners who don't qualify for regular type farm dwellings from building mansions that permanently take farms off of the farm land market.

Stop this war on conservation of our farm and forest land. Home builders, Realtor groups, OPOA and Oregonians in Action have never wanted any land use laws or any protection of Oregon. Don't be decieved.

I am a first generation commercial farmer in Parkdale. I make all of my living farming, raising apples, pears, cherries and managing forests. I have been involved in supporting conservation of farm and forest land in Oregon for 44 years. I represent Ag for Oregon, a group of farmers, ranchers and forest land owners who believe in strong protections for our working lands.

Without the Oregon Land Use program there would be little farmland left in Hood River County. The fruit industry would have been lost to residential and resort development. Please remember that the anti land use groups supported subdividing 10,000 acres of the Hood River Valley orchard lands as well as much of the Willamette Valley. They will not quit until they have achieved this. Their strategy is to create vague language that opens up the doors to any and all commercial and residential uses on Oregon's farm lands except farming.

The whole intent of the Oregon Land Use System proposed by a farmer, Hector MacPherson was to keep farm land prices low so the land would remain in farm use. Limiting non farm uses was the

essential tool. Now, over time every possible non farm and non forest use has been allowed escalating land prices and moving commercial uses out of our rural communities on to farm and forest land.
