My name is Jared Peacock, and I am writing to express my strong support for House Bill 3193, which establishes a **permanent farmworker disaster relief program** in Oregon. This bill is a critical step in ensuring that farmworkers—who are essential to our state's agricultural economy—receive the financial support they need when disasters disrupt their livelihoods.

Farmworkers Are Essential, Yet Vulnerable

- Farmworkers who **lose wages or income** due to disasters—including those who experience reduced hours due to slower work conditions—would be eligible for assistance.
- The relief program would provide funds to cover **reasonable and necessary living expenses** for affected farmworkers.
- 2. **Eligibility Based on Disaster Impact**
- Applicants must show that they **lost income due to a qualifying disaster** and provide their **employment location (zip code and county)** at the time of the

disaster.

- This ensures that funds go directly to farmworkers experiencing financial hardship.
- 3. **Implementation Through the Oregon Health Authority (OHA)**
- The OHA will **partner with worker relief organizations** to distribute funds efficiently.
- The bill allocates **\$10 million from the General Fund** to establish and implement the program for the 2025-2027 biennium.

- **Disaster Relief is a Matter of Equity**
Farmworkers—many of whom are immigrants or low-income workers—often **do not qualify for traditional relief programs**. HB 3193 ensures they receive assistance

- **Economic Stability for Oregon's Agricultural Industry**

 Supporting farmworkers **stabilizes the agricultural workforce**, ensuring farms can recover quickly from disasters and maintain food production.
- **A Permanent Safety Net for the Future**

 Oregon has seen an **increase in extreme weather events and emergencies**. A

 permanent relief program will prevent future economic crises for farmworkers
 when disasters strike.

HB 3193 is a **practical, compassionate, and necessary** policy that upholds Oregon's commitment to its essential workers. I strongly urge the Legislature to **pass this bill** to ensure that farmworkers—who sustain Oregon's food supply—are protected when disasters disrupt their livelihoods.
