Dear Chair Lively, Vice Chair Levy, Vice Chair Gamba, and Members of the Committee:

My name is Mike Powers and I am the Immediate Past President and a Policy Strategist with our Union, SEIU Local 503. We represent over 72,000 Oregonians who serve in every county in the state. Thank you for the opportunity to provide testimony in favor of HB 3477.

In a summary of the Oregon Climate Assessment released in January 2025, Erica Fleishman, Director of the Oregon Climate Change Research Institute, emphasized that the assessment "underscores that understanding, mitigating, and preparing for climate change is a priority for the state of Oregon." Our union's leadership fully agrees with this priority, as demonstrated by a 2022 General Council resolution committing our members to engage in climate-related legislative efforts. We are focused on minimizing the harmful impacts and costs of climate change while seizing the opportunities that come with the transition to clean energy alternatives.

Since the creation of the Oregon Climate Action Commission (formerly the Global Warming Commission) in 2007, climate science has advanced, revealing that the impacts of climate change are more severe and immediate than we previously understood. The latest Oregon Climate Assessment provides in-depth, peer-reviewed scientific data to support this.²

In response to this new information, HB 3477 proposes updated goals to reduce our state's greenhouse gas (GHG) emissions. The modeling shows that meeting these goals would not only help the environment but also bring significant economic and public health benefits, including an estimated \$120 billion in cumulative net benefits and over 350,000 new jobs in Oregon by 2050.
