As a rancher in Eastern Oregon, I am adamantly opposed to HB 2548 and I strongly encourage you to oppose it as well.

When I began writing this testimony, it was difficult to know where to begin. There are so many factors that make this a very frightening and threatening bill that you all will be considering and I sincerely hope you will take the time to read through the provided testimonies from so very many Oregonian citizens across our state. While the intentions of the sponsors may seem noble and justified they are not founded on facts or reality. Oregon is in the top ten states in our nation in wages paid to employees. Oregon has very strict OSHA rules, overtime benefits, employee housing requirements, safety precautions, and the list goes on.

We are not heartless and abusive to those who come to work and toil alongside us. We must be allowed to have the flexibility to operate the way we know best for our farms and ranches. This ludicrous bill is more of the government overreach and regulations that have helped put Oregon agriculture in the predicament that we see today. I ask you, how many of these unelected boards that are creating requirements are truly effective? How many of these unelected boards have people on them that truly know and understand all the intricacies of the business they are dictating too?
