In opposition of HB 3075

HB 3075 is a bill that hinders law abiding citizens from their Constitutional rights, both Federal Constitution and State Constitution. For State purposes; Right to bear arms: The people have the right to bear arms for self-defense and the defense of the state, but the military must be subordinate to civil power. Clear that Legislators are barred from denying citizens from their ability to self-defense.

State Denials: A permit is no different than asking permission to exercise a right that is not a true right at all, especially when that State can deny the permission by various means, by incident or deliberately. Further, a permit given, is a permit denied. Violation of Article 1; Section 9.

The permitting being added fees also disadvantages those of lower income brackets more than before. This is merely a financial infringement, if forcing everyone to buy EV's against their will and ability. And since statistically, minorities tend to be in the lower economic brackets, this very bill also targets by race, the very thing Democrats vow to protect, now denying. No wonder in part why minorities have shifted greatly away from Democrat Isle. Keep in mind, it's been Democrats who have been pushing HB3075/M114.

State deny by system: The fact that HB 3075 and Measure 114 require FBI to do background checks, and FBI has denied those background checks. The fact that Oregon Legislation is forcing FBI to be the designated background checkers while knowing that background checks will not happen is no different than blocking and prohibiting a right.

Will of the People may have passed Measure 114, but it does not mean that the Measure is a Constitutional Measure. Measure 110 was passed by the People, and yet, Oregon Legislator reversed the measure after drug addiction increased like never before, hundreds more children died from overdosing and exposure, thousands more yearly died all laid out in the streets all over Oregon: no help avail.

Suicide rates by gun is smaller contribution to suicides compared to suicide by rope, overdosing, drowning, or other forms. Suicide is barely comparable. To say that denying someone a firearm will stop any suicide is far from accurate. Japan and S. Korea, two developed countries that have total banishment of any firearms, have by far higher suicide rates than rest of the word. The notion that denial of firearm ownership is completely futile argument. Further, denying a method of suicide does not stop a suicidal person from suicide, as there are many other ways, and Measure 114/HB3075 does nothing to deal with the distress and/or disturbance of someone

who is suicidal.

Crime rate is not even effected by HB3075/M114 at all. Since when has a convict with a criminal record, domestic violent conviction, felon, or worse ever walked into a sporting goods shop or gun shop to purchase a firearm? They will be denied and criminals already know that. Further, criminals knowing that citizenship become easier and softer targets enables more criminal activity and crime rate rise even more. Past 5 years, crime rate in Oregon has only increased by double digits across the board because criminals targets are softer. Why would a criminal want to mug someone in Idaho when Oregon is softer? In recent years, criminals have gotten away with rape, theft, and even murder even after being arrested. Oregon to the rest of the nation is a heaven for crime.
