9A and 14A the rights of one do not outweigh the rights of the many

Justice Scalia said in Heller, arms are anything used for defense or offense, that all arms in common and for lawful purposes, and the attachments needed for them to operate ARE PROTECTED ARMS! Scalia also told us that when considering if a modern day law is constitutional, must look at the history and the text at the time of the ratification (1791 not 1868, 1934 or 1968) and if no law existed, or is not rooted in a law at that time, the current day law is illegal, unconstitutional and cannot be enforced HB 3075/Mz114 is unconstitutional! The Bruen decision took it further to say that if a citizen falls within the text of the Amendment, the burden of proof shifts to government, no law existed for any provision in HB3075 in 1791. Justice Scalia told us that we have the right to carry our commonly used for lawful weapons outside the home, over 20 million AR 15's alone in the US constitutes they commonly used arms, HB 3075 is unconstitutional.

When considering if a law is constitutional Scalia said that we must look at the language of that era. Old English was spoken and that time and the phrase The right of the people to keep and bear arms shall not be infringed in old English means the government may not interfere or hinder our right. HB 3075/Mz114 hinder and interferes with our constitutional right!

Over 700 mil magazines in use in the US that hold more than 10 rounds. All magazines are designed for a particular gun and therefore are protected arms. There were no laws on the books that required anything required in HB 3075 in 1791, therefore HB 3075 is unconstitutional. Banning any magazine that holds more than 10 rounds renders arms that require that magazine useless, thus creating a gun ban, this violates the constitution as stated in Heller.

Banning magazines with a detachable floor plate is a sneaky way to establish a gun ban, a violation of the constitution!

It is unconstitutional that we must ask the government for permission to exercise our inalienable right and it's tyrannical that government gets to choose who can exercise that right and who can't. There is no requirement for the police to respond so a right delayed is a right denied and denying a right violates the constitution.

Requiring citizens to pay a tax or fee to exercise a right is a violation of the constitution in the 24th amendment and was just struck down by the 3rd Circuit.

Collecting, archiving purchase and ownership records is a violation of The Gun Control Act of 1968.

This all has been ruled unconstitutional by the Supreme Court in the Heller, McDonald, Caetano and Bruen rulings. The Supreme Court has stated they are exhausted with the inferior courts getting it wrong...these inferior courts they refer to are all in liberal democrat controlled states. Nothing in HB 3075 is constitutional.

There is no program in place to initiate HB 3075. in Mz 114, County Sheriff's testified they do not have the personnel to enact this, HB 3075 puts the community, especially rural communities' safety in severe risk! This creates two problems; the safety of Oregonians, and it denies citizens the ability to exercise our constitutional right.

Nothing in HB 3075/Mz 114 is constitutional and as we all know, the democrats will vote this into law, violating everyone's constitutional freedoms, millions more will be spent on fighting a law that has already been fought and lost at the supreme court. How much more must the public endure to get a political body to understand they do not get to take any and/or all constitutionally protected rights from the citizens, they do not have the legal right to tell us who can and can't exercise any right, and they cannot ban, restrict or remove any right or freedom without a conviction!
